**Three More Videos Show
Planned Parenthood
Helping Sex Traffickers**

Live Action released today three more videos from the undercover investigations it conducted earlier this month of Planned Parenthood abortion centers helping alleged sex traffickers obtain abortions for underage girls.



The three new videos, covering Planned Parenthood centers in Virginia, join the two other videos the group has released of a Perth Amboy, [New Jersey abortion business](#) and [a Planned Parenthood center in Richmond, Virginia](#) — both of which had staffers helping the alleged sex traffickers find information on how to obtain abortions without facing scrutiny and get STD testing for the girls.

A Planned Parenthood staffer in New Jersey [has already been](#)

[fired](#), New Jersey officials [are looking into](#) a shoddy abortion center Planned Parenthood referred to in its video, and the Virginia attorney general [has received](#) the full footage of the Richmond Planned Parenthood expose’.

All three of the new videos clearly show staff willing to aid and abet the sexual trafficking and exploitation of minors and young women and the videos, Lila Rose of Live Action says, provide more evidence of a clear, disturbing pattern of gross misconduct by Planned Parenthood.

The three new videos includes a Roanoke, Virginia abortion facility staffer suggesting the sex trafficker consider going to the health department instead of taking the girls he is victimizing to the Planned Parenthood — because it would be easier to hide the illegal activity.

“They’re discreet. They’re confidential. They, you know, don’t tell people what’s going on, because — frankly — it’s nobody’s business,” the female Planned Parenthood staff person is shown saying on the video.

“And the thing is, see this is the thing a lot of people don’t know that. . .Right, through the Health Department.”

The videos shows giving birth control and STD testing for underage prostitutes is no problem.

“From the age of 12 up, for birth control, you can just come in and do that. You don’t have to have a parent, OK?”

Another one of the new videos depicts Planned Parenthood staff in Falls Church, Virginia telling the sex traffickers, “We don’t necessarily look at the legal status, like I said. Abortion appointments do require photo ID. It’s nothing as far as records. It’s just photo ID that’s ever going to be required.”

And a video of a Charlottesville, Virginia Planned Parenthood center conversation with the sex traffickers has the staffer assuring them that “Anybody here can help you. Everything here is confidential. We can’t give any information out” —

even after being informed that illegal activities are occurring that they wish to hide via Planned Parenthood.

“It is utterly disgusting that Planned Parenthood’s response to this is that their employee reacted ‘professionally,’” said Live Action President Lila Rose.

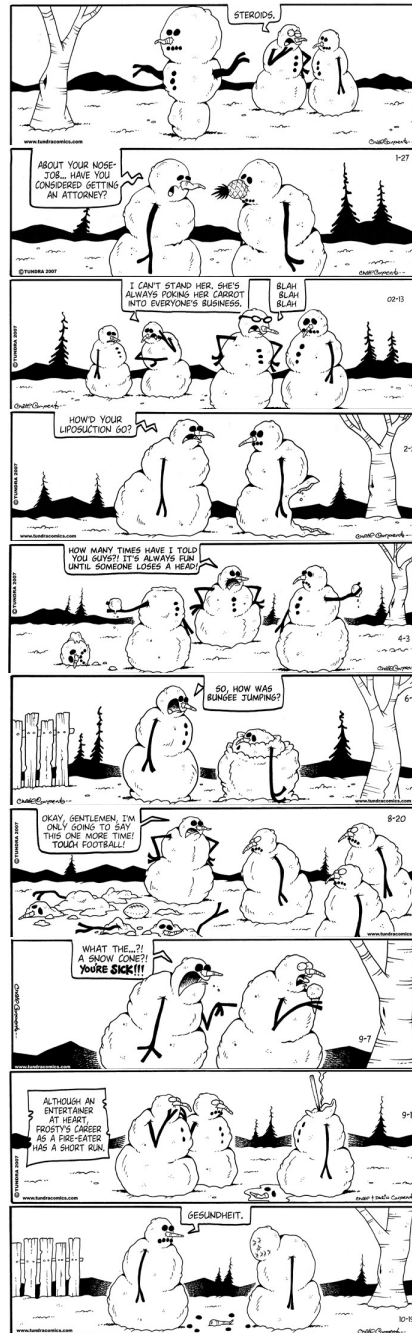
“The only acceptable response to encountering a self-identified sex-trafficker of underage girls is zero tolerance. The only ‘professional’ response is to immediately call law enforcement to the scene and push for an arrest. Our investigation – and their response – continues to show that an institutional crisis has engulfed the highest levels of Planned Parenthood. If you’re a sex-trafficker of minors or young women, you have a partner in Planned Parenthood. But if you are a minor or a young woman, you are not safe at Planned Parenthood clinics,” Rose continued.

The footage shows a man who

identifies himself as a pimp working with underage girls. He seeks assistance for getting abortions, STD testing and birth control for girls he “manages” as sex workers, who are from out of the country and as young as 14 to 15 years old. The investigation continues to unearth alarming evidence that Planned Parenthood, which receives more than \$350 million from the American taxpayer every year, is willing to facilitate the sexual exploitation of minors and young women.

“Today, we are sending Attorney General Cuccinelli and Virginia law enforcement officials new, disturbing footage from three Virginia clinics. The footage explicitly shows Planned Parenthood staff willing to engage in activity that sexually exploits minors and young women. The evidence continues to mount, and shows a clear pattern where Planned Parenthood is willing aid and abet the sex-trafficking industry. These are abhorrent practices and it is time Planned Parenthood be held accountable,” Rose said.

Second Video Shows Planned Parenthood-Sex Trafficking Coverup

A second videotape has been released showing a Planned Parenthood abortion business covering up an alleged sex trafficking ring. The first tape showed staffers in New Jersey engaged in the coverup and this one features a clinic in Virginia. The undercover investigation sponsored by the pro-life group Live Action features the same setup in this second video: a sex ring operator and one of his prostitutes visit the Richmond Planned Parenthood abortion center looking for information about how to obtain abortions for the minor girls they allegedly illegally brought to the United State.

The new Richmond video presents a similar scenario as the New Jersey video. A man posing as a pimp and accompanied by his "bottom girl" seek assistance for getting abortions, STD testing and birth control for girls they "manage" as sex workers, who are from out of the country and as young as 14 to 15 years old.

One again, the sting operation has Planned Parenthood officials willing to bend over backwards to get abortions for the victimized girls and, in this case, bragging about how they can

undermine the judicial bypass provision in the Virginia parental notification law to get a judge to approve the secret abortions on the sex slaves.

"But there are also ways, like judicial bypass, that we can get around that if you guys ever need it," she says of how to get abortions for the 14 and 15-year-old girls they say are here illegally. "There is a way to avoid that."

State Health Department to Probe Abortion Center in Video

The New Jersey state health department will investigate a shady abortion business a Planned Parenthood official mentioned in an investigative video showing staff at Perth Amboy Planned Parenthood aiding sex traffickers. In the video that has captured national attention, the pair of alleged sex traffickers visit Planned Parenthood Central New Jersey's abortion center in Perth Amboy and clinic manager Amy Woodruff, an LPN who has since been fired, warns the pimp and his prostitute to have their trafficked underage girls lie about their age to avoid mandatory reporting laws.

"Even if they lie, just say, 'Oh he's the same age as me, 15, it

is just that mainly 14 and under we have to, doesn't matter if their partner is the same age, younger, whatever, 14 and under we have to report," Woodruff says. "Like on the paperwork there is going to be a point that asks, uh, like are you sexually active, stuff like that if they're under a certain age you know, me and my other counselor, like for the most part we want as little information as possible cause we don't want to be involved."

Woodruff also coaches the alleged sex traffickers on where to get an abortion that won't be met with as much scrutiny, referring them to the New Jersey-based abortion business named Metropolitan Medical Associates, where she says "They won't need ID then. Their protocols aren't as strict as ours and they don't get audited the same way we do." That comment, according to the Star-Ledger newspaper, has prompted state health officials to investigate whether underage girls at the Metropolitan Medical Associates are obtaining abortions without disclosing the age of their sexual partner.

Attorney General Seeks Quick Supreme Court Review of Obamacare

Lawsuit

Virginia Attorney General Ken Cuccinelli announced today that he will file a petition on behalf of the state with the Supreme Court to ask it to take an expedited review of the lawsuit he filed to declare Obamacare unconstitutional.

Leading pro-life groups are united in their opposition to Obamacare because of abortion-funding and rationing concerns within the legislation.

Cuccinelli's move comes just days after a Florida federal judge ruled the entire Obamacare law unconstitutional in a separate lawsuit Florida and more than two dozen other states filed. They challenged the individual mandate "which compels Americans to purchase health insurance that could fund abortions with taxpayer funds or premiums" and the federal judge in the case ruled the mandate, and therefore the entire law, unconstitutional. A Virginia federal judge ruled the individual mandate invalid but not the entire Obamacare law in his decision in the lawsuit Cuccinelli filed. Two other federal judges have issued rulings saying the individual mandate is constitutionally valid. It is because of these varied decisions that the Virginia attorney general is

moving ahead.

Planned Parenthood Attacks Videos of Sex Trafficking Coverup

In a CNN interview yesterday, Stuart Schear, Planned Parenthood's vice president of communication, refused to appear on the program with Live Action president Lila Rose to discuss the new expose videos her group revealed. The videos showed Planned Parenthood engaging in a coverup of sexual trafficking by not showing any alarm over the illegal activities of two sex traffickers forcing young girls to have sex and obtaining abortions for them when pregnant. Instead, the abortion business guides them through obtaining STD testing and getting abortions without parental involvement. During the CNN interview, Planned Parenthood aggressively attacked Rose and her group rather than explain why its employees would assist sex traffickers.

One last point, which is that the organization that is coming in and secretly taping within Planned Parenthood health centers- they are not concerned about women and they're not concerned about abused young girls, he claimed. They have

a very extreme political agenda, which is to outlaw abortion for all women in the United States, and to take the constitutional right away, and they are working with other groups to make sure that federal funds are taken away.

Obama Administration Accused of Spiking CDC Abortion Data

The Obama administration is facing accusations today from a conservative web site that alleged the Centers for Disease Control is purposefully spiking annual data it normally publishes concerning the latest abortion stats and figures.

Erick Erickson of Red State says it has uncovered evidence confirmed by the CDC's own press office that the Obama administration is deliberately concealing the abortion numbers. Erickson noticed that the CDC did not put out the annual information it normally publishes in November, called the Abortion Surveillance Report, and said press officers for the agency said there were no plans to do so.

The report, which typically posts the abortion data from three years prior to the 2009 report featured 2006 abortion data will not come out now because Erickson says RedState

MoveOn.Org Helps Planned Parenthood After Sex Trafficking Coverup

The liberal activist group MoveOn.org is helping the Planned Parenthood abortion business in the wake of videos showing its staff aiding two alleged sexual traffickers with obtaining abortions and STD testing for underage girls. The videos have already prompted a Planned Parenthood affiliate in New Jersey to fire a staffer and the New Jersey attorney general is looking into the allegations behind the video and checking out a shady abortion business to which Planned Parenthood makes referrals.

Rape Language Dropped From Bill Banning Tax-Funded Abortions

Language that pro-abortion advocates misconstrued as weak on the issue of rape has been dropped from a bill pro-life groups are strongly supporting that would ban federal taxpayer funding of abortion. HR 3, the No Taxpayer Funding for Abortion Act, rolls several federal rules that have to be

passed annually to prevent taxpayer funding of abortions in various governmental departments and programs into one permanent federal law. It would also remove any concerns from the Obamacare law that it could somehow be used to finance abortions with federal funds.

But NARAL, Planned Parenthood and other pro-abortion activists claim the bill, by changing the rape exception language to include "forcible rape" suddenly attacks women victimized by rape.

Douglas Johnson, the legislative director for the National Right to Life Committee, explained to LifeNews.com that that is not the case, and said the bill would codify the substance of the policy that was in place from 1993 on when Congress added rape and incest exceptions to the Hyde Amendment for lack of votes of keeping abortion funding limited to life of the mother only.

Abortion Biz Fires Staffer in Sex Trafficking Video

The Planned Parenthood abortion clinic staffer who appears in a new undercover investigation video assisting two people who claim to be heading up a sex trafficking ring has been fired.

Late Tuesday night, Planned Parenthood of Central New Jersey released a statement saying the staff person, Perth Amboy center clinic manager Amy Woodruff, would be let go.

□ We were profoundly shocked when we viewed the videotape released this morning, which depicted an employee of one of our health centers behaving in a repugnant manner that is inconsistent with our standards of care and is completely unacceptable, □ Phyllis Kinsler, executive director of the local affiliate, said a statement, according to NJ.com.

□ We have a zero tolerance policy for this kind of behavior, and the employee in the video was immediately suspended from her duties this morning and was terminated this evening, □ Kinsler said. We are fully committed to delivering high-quality reproductive health care to the women of our communities, complying with all laws, and upholding the highest ethical standards. □ Planned Parenthood officials

were reportedly unaware of what Woodruff told the couple involved in the undercover investigation.

Pro-Lifers Demand Planned Parenthood De- Funding After Expose □

The reaction from the national pro-life community to a new video released by a group exposing the Planned Parenthood abortion business has been swift and decisive: they want Congress to yank federal funding for Planned Parenthood. Taxpayers Stuck With Legal Bill for State Officials Ignoring Gosnell

When the grand jury report came down that was used to charge abortion practitioner Kermit Gosnell and his staff with murder charges and other counts related to the death of a woman and seven infanticide cases, state officials were accused of ignoring abuses. Now, new documents a local television station uncovered show taxpayers were forced to pay for the legal bills of those state officials who ignored the abuses that could have closed the clinic and saved the lives and health of countless women and babies who were purposefully prematurely birthed for the purpose of killing them with medical scissors.

Fox 29 indicates Pennsylvania state records it obtained show taxpayers forked over \$100,000 in legal bills for attorneys for the state officials the grand jury subpoenaed. The local prosecutors in the case grilled the state officials and they were entitled to legal representation, but chose to accept public attorneys paid for at public

expense.

The total cost to taxpayers was over \$116,000 for the attorneys picked by a Center City law firm that earned over \$50,000 in fees connected with the representation of the state officials. The new information adds insult to injury in a case that has received national attention for the gruesome and horrendous practices at Gosnell is abortion business.
