#### **Obama Selects Ex-Planned Parenthood Board Member as Appeals Judge**

President Barack Obama named a current Alaska Supreme Court justice who is a former Planned Parenthood board member as a nominee to a federal appeals court, in what is his latest pro-abortion judicial selection. Yesterday, the White House announced Obama has named Justice Morgan Christen to the 9th Circuit U.S. Court of Appeals. She has served as an Anchorage Superior Court Judge for seven years before pro-life former Alaska Gov. Sarah Palin named her to the state Supreme Court □ having to choose between two pro-abortion candidate given to her by a judicial selection panel. When she submitted her application to become a state Supreme Court justice, Christen made no mention of the fact that she is a former board member of

Planned Parenthood and served the pro-abortion group in the mid 1990s. Knowing that information, Jim Minnery, the director of the Alaska Family Council, a pro-life group, opposed her nomination because she would become another activist on the Court. □ In his statement announcing Christen's nomination, Obama said, I am proud to nominate this outstanding candidate to serve on the United States Court of Appeals. I am confident Justice Morgan Christen will serve the American people with integrity and distinction. □ Christen's appointment will come before the U.S. Senate, where Republicans will likely oppose her nomination, but they will have to do so without the support of Republican Sen. Lisa Murkowski, who told the Alaska Daily News that Obama's selection of the abortion proponent is □ an outstanding choice to fill Alaska's sole seat on the 9th Circuit.

#### **Senate Backs Filibuster of Pro-Abortion Nominee Goodwin Liu**

The Senate votes today against a motion by Senate Democrats to cut off debate on Goodwin Lui, a pro-abortion law professor President Barack Obama selected to become a judge on a federal appeal court.

The Senate Judiciary Committee approved Liu's nomination for the federal appeals court in the western United States in April on a 10-8 party line vote. Liu, a liberal University of California law professor, faced opposition from Republicans while getting support from each of the Democrats on the committee and Republican lawmakers have filibustered his nomination, calling him too extreme to be approved.

Today's vote saw Senate Republicans uphold their filibuster 52-43 with Republican senators Lindsay Graham, Dick Lugar, John McCain, Olympia Snowe, Susan Collins and Scott Brown all voting to stop the nomination from moving forward. Democratic Sen. Ben Nelson of Nebraska joined them while □pro-life Democrats□ Bob Casey and Joe Manchin voted to allow the nomination of the abortion activist to move ahead.

Lisa Murkowski, a pro-abortion Republican, was the lone GOP vote for ending the filibuster. During the debate leading up to the vote, Senator Orrin Hatch of Utah, a member of the committee, outlined his strong opposition, saying Liu has □activist judicial philosophy is fundamentally at odds with the principles on which our system

of government is based. □When I look at Professor Liu's record, I see that he consistently and strongly advocates an approach that allows judges to find the meaning of the Constitution virtually anywhere they want to look,□ Hatch said. □That is the opposite of the defined, limited role that judges properly have in our system of government. I cannot support someone for appointment to the federal bench, especially to what is already the most activist circuit in the country, who believes judges have that much power.

### **Planned Parenthood Abortion Biz in New Jersey Violating Laws**

A recent inspection of a Planned Parenthood abortion center in New Jersey finds the facility is violating several different health and safety laws designed to protect women. The news comes after another facility, earlier this year, was caught offering to arrange abortions on victims of sex trafficking.

In early February, an employee at the Planned Parenthood abortion facility in Perth Amboy, New Jersey was caught on videotape working with an alleged sex trafficking ring operator to get abortions done on the underage girls he

claimed he was exploiting. Now, a new inspection last month of Planned Parenthood of Mercer County finds the clinic in the state capital was cited for numerous health code violations which have placed the lives and health of women and young girls in imminent danger.

The New Jersey Department of Health conducted the surveys on March 10 and 11 and found Planned Parenthood of Mercer County improperly used syringes and compounds, it was guilty of improper training and qualifications of staff on pain management and health care counseling (including abortions), the facility failed to have infection control program in place and failed to require physical exams for staff. Health officials also determined the Planned Parenthood center did not test staff for rubella and TB, the medical director failed to designate a replacement for times of absence, the Planned Parenthood did not ensure adequate protections were in place for drug adverse reactions and medication errors, did not have procedures in place regarding dangerous substances, did not have a written agreement with a pharmacy licensed by the New Jersey State Board of Pharmacy, did

not have adequate infection controls in place, was not using and sterilizing medical instruments and devices □ including a vaginal ultrasound □ properly, and did not provide any proof that the facility is a formal member of the Maternal and Child Health Consortium as required by law.

### **Pro-Life Gov. Tim Pawlenty Announcing GOP**

#### **Presidential Bid Monday**

Former Minnesota Gov. Tim Pawlenty is expected to announce on Monday that he is officially declaring his candidacy for the Republican nomination for president. The governor has built up a pro-life record that is appealing to social conservatives.

Pawlenty's campaign for the Republican nomination will have him become part of a field that is ultimately expected to be less crowded than previously though thanks to decisions by Mike Huckabee, Donald Trump and Haley Barbour to not seek the GOP nomination. Huckabee's decision, in particular, is seen by many political observers as given Pawlenty a chance to resonate with pro-life voters in states like Iowa and South

Carolina.

A Pawlenty aide confirmed to the Associated Press today that the announcement is forthcoming and the governor will make the announcement at 11:30 a.m. at the Historical building in Des Moines, Iowa a state where Pawlenty has said he needs to do well in order to springboard to the upper echelon in the polls and capture New Hampshire and other states that vote next.

After the announcement, Pawlenty is expected to deliver speeches in the Granite State along with Florida, New York, and Washington, D.C.

The former governor served as a state legislator and local city official before heading up the largely Democratic state □ where he won two consecutive statewide elections with an increasing percentage the second time around in what was otherwise a poor 2006 election year for Republican candidates. During his time as governor, Pawlenty built up a sterling pro-life record and worked closely with Minnesota Citizens Concerned for Life to advocate the pro-life position. Following Governor

Pawlenty's two terms, the number of abortions dropped 14 percent and reached a 35-year low.

Governor Pawlenty has been a powerful ally of MCCL and the pro-life movement for many years. He strongly supports life-affirming legislation to inform and support pregnant women, who are now feeling empowered to give life to their unborn babies, says MCCL executive director Scott Fischbach.

### **Herman Cain to Announce Run for GOP Nomination Saturday**

Businessman Herman Cain will announce tomorrow he is officially a candidate for the Republican nomination for president. The Georgia-based businessman will make the announcement in his home state.

Cain, a former Atlanta conservative talk radio show host and former candidate for the U.S. Senate in Georgia, is expected to inform friends, family and supporters of his decision at a rally Saturday at Centennial Olympic Park. Cain is also the former chairman of the Federal Reserve Bank of Kansas City and is running on the Republican side along with former Georgia congressman

and House Speaker Newt Gingrich. The former Godfather's Pizza CEO turned in a performance at the recent debate in South Carolina with other possible Republican presidential hopefuls that inspired watchers and elevated him slightly from his low ranking in the polls both nationally and in key early primary and caucus states like Iowa and New Hampshire.

### **Kate Walsh Plugs Pro-Abortion Propaganda on Private Practice**

As far as I'm concerned, there's a circle in Hell reserved for late-term abortionists. But this is the Obama era, so Hollywood makes TV shows casting them as heroic figures. Such is the state of our popular culture.

On the May 12 episode of ABC's "Private Practice," Dr. Addison Montgomery (played by actress Kate Walsh, a real-life Planned Parenthood activist) spewed the strongest pro-abortion "pro-choice" rhetoric as she performed a partial-birth abortion on a woman who thought she'd already had an abortion two months before.

"I hate what I'm about to do, but I support Patty's right to choose," the doctor declares. "It is not enough just to have an opinion, because in a nation of over 300 million people, there are only 1,700 abortion providers. And I'm one of them." "The poor, poor killer of babies. ABC should have cued the orchestra to swell up and champion the few and the proud, followed by the on-screen credit, "This message brought to you by Planned Parenthood." It was that

blatant.

There were no cheers for this very special episode from the usual liberal TV critics, and feminist groups weren't shaking pom-poms either. But there's probably a Planned Parenthood "Maggie Award for Media Excellence" in ABC's future. Walsh won this award in 2008 for her "extensive advocacy efforts on behalf of affordable family planning services and real sex education."

### **Texas Gov. Rick Perry Signs Ultrasound Before Abortion Bill**

Thanks to Governor Rick Perry, legislation that will allow women who are considering an abortion to see an ultrasound of their unborn child beforehand will become state law.

"Governor Perry was pleased to sign this important legislation, which bolsters our efforts to protect life by ensuring Texans are fully informed when considering such an important decision," said Katherine Cesinger, a spokeswoman for the governor, according to various media reports. The legislation allows women to see the ultrasound 24 hours before the abortion and abortion centers typically do ultrasounds to estimate the age of the baby before the abortion but they don't normally allow women a chance to see or explain to them in detail the development of their unborn child. When used in pregnancy centers offering abortion alternatives, approximately 80 percent of women change their mind about

having an abortion. Women who live 100 miles or more from an abortion center wait two hours from the ultrasound to the abortion and they are given the option to decline to view the ultrasound.

The Senate passed the bill on second reading on a 21-10 vote and all hostile, pro-abortion amendments by Sens. Wendy Davis, Jose Rodriguez, and Leticia Van de Putte were defeated. After the Texas Senate signed off on the legislation, the state House, on a 94-41 vote, voted to concur on the Senate changes to HB 15, the sonogram bill.

### **Paralyzed Man Stands, Takes Steps After New Treatments**

It isn't a "cure" (a term *way* overused in health care stories), but it could one day improve the lives and health of millions of people with spinal cord injury. [From the story:](#)

A man left paralyzed after a car accident was able to stand and take steps after electrical stimulation of his spinal cord in what researchers described as a breakthrough in treating such devastating injuries. Rob Summers, a 25-year-old former college baseball pitcher, can also move his hips, knees, ankles and toes — and has regained some bladder and sexual functionality, researchers said on Thursday.

"It opens up a huge opportunity to improve the daily functioning of these individuals ... but we have a long road ahead," said Susan Harkema, lead researcher of the study from the University of Louisville in Kentucky. The results were published in *The Lancet* medical journal. "This is not a cure, and Rob's not walking. ... Short of that, this approach may have impact in incremental ways," she said. "Allowing people to just stand a few minutes a day can dramatically change their health."

Summers received continual direct electrical stimulation of the lower spinal cord, a process designed to mimic signals the brain normally transmits to initiate movement. The researchers spent more than two years retraining Summers' spinal cord's neural networks to produce muscle movements, after which the electro-stimulation device was surgically implanted in his back.

The late Christopher Reeve was sold a bill of goods back in the day: ESCR was not—and never was—the "only hope" for paralytics.

By the way, much of the knowledge about the interaction between brain and spinal cord that allowed this wonderful achievement undoubtedly resulted from animal research.



## Virginia Health Dept

### Rejects Planned Parenthood Expansion

The Virginia Health Department has rejected a request by the Planned Parenthood abortion business to expand the number of operating tables at its facility in Virginia Beach, where pro-life advocates expect more abortions to occur.

Planned Parenthood of Southeastern Virginia wants to add two operating rooms at the facility it operates on Newtown Road that it opened in 2010, where it does abortions and provides some non-abortion services. A Certificate of Public Need (COPN) hearing was held at the Virginia Beach Central Library on Monday with a crowd of 80 people evenly divided in presenting their thoughts to the two-person panel making the decision.

Planned Parenthood claims the two new operating rooms are needed to expand their non-abortion services — which pro-life advocates say are merely a way to try to draw attention from its status as the number one

abortion business in the country. The expansion would cost Planned Parenthood \$225,000.

The Virginian-Pilot reports today that the state health department initially declined the request and recommended to the state health commissioner, who will issue the final decision later this year, that the expansion plans be denied. State officials say there are already plenty of operating rooms in the region and said Planned Parenthood didn't show a unique need for its expansion when "reasonable alternatives" are available.

"Improving access to existing operating rooms is a more economical and efficient alternative to adding capacity," the state said, adding that it could maintain a list of legitimate health centers to refer women to who want non-abortion care. "We're obviously

very disappointed,” Erin Zabel, a Planned Parenthood spokeswoman, told the newspaper. “We know that they’re needed services because our patients tell us, the people in the community tell us.”

The Virginian-Pilot indicates the mayors of Newport News and Portsmouth and three state legislators supported the plan while the CEO of Bon Secours Hampton Roads Health System opposed it saying the medical center has plenty of space to treat non-abortion patients. Zabel did not say if Planned Parenthood would pursue the expansion plans further.

During the hearing earlier this month, local pro-life residents said they were concerned the operating rooms would be used to bring second-trimester abortions to Virginia Beach.

“Abortions are what they do,” said Louantha Kerr, who is with

40 Days for Life Virginia Beach, who noted that thousands of people signed a petition against the abortion center when it opened last year. “Those same 10,615 citizens are saying again today that they don’t want Planned Parenthood to be granted two operating rooms to do more abortions – later-term abortions.”

“The real planned agenda is to expand into the lucrative second trimester abortion business and they would have a monopoly in Hampton Roads,” one woman said.

Another woman accused Planned Parenthood of targeting minorities by building and expanding abortion centers in historically black communities.

COPN Project Supervisor Peter Boswell told people attending the hearing that there are eight criteria the panel uses to evaluate requests like Planned

Parenthood's. he also said members of the public can still voice their views by going to <http://www.vdh.state.va.us/OLC/COPN/> at the Virginia Department of Health web site. The final decision is expected by May 19, according to the Daily Press.
