## 2018 Kenner Louisiana Reunion



The Vietnam Veterans of the 2nd Battalion 1st Marines, Inc. held its 2018 reunion in Kenner, Louisiana, in the greater New Orleans metro area from 7 - 12 November. As typical with our membership, many VV 2/1 members used the hotel's room rate extensions to come to the area early and, for several members, stay beyond the reunion dates to explore the area.

VV 2/1's "Official Excursion" was a group trip to The National WWII Museum in the Warehouse District of New Orleans. The Museum was the

brainchild of several prominent individuals, notably the late author, Stephen Ambrose and actor Tom Hanks. Over 100 members and their families attended the reserved showing of the multi-sensational movie "Beyond All Boundaries," where your seat vibrates as the tank scenes appear and snow falls during winter scenes.

Following our reserved movie presentation, we were free to explore the extensive campus of the Museum. Displays of an original B-17 and a B-25 in ceiling suspension to small squadrons of fighter and observation aircraft, made the Museum's flight pavilion dramatic and impressive. Equally impressive were the displays of the various WWII campaigns of Europe and the Pacific, which were complemented by in-depth presentations of Bob Hope's WWII troop entertainment trips as well as the story of the last voyage of the USS Tang. And, the Museum restaurant was very good, endorsed by the number of VV 2/1 members lunching at the establishment.

Throughout the week, members also took many local walking tours, plantation tours, visited Mardi Gras World and generally explored New Orleans. Of course, the requisite trips to Bourbon Street, The French Quarter, taking in jazz along Frenchman Street or beignets at Café Du Monde were made by many VV 2/1 members while in the city. The good news is that all revelers returned safely.

As with our 2017 Washington DC Reunion, the hotel accommodated VV 2/1 by providing a buffet breakfast in our designated Hospitality Room. That afforded the membership to dine at their leisure among the membership. It worked very well for us. We shall continue this as much as practicable at future reunions.

In recognition of our attendance numbers, the hotel sponsored a wine-and-cheese reception one evening. It was a good "mixer" and well attended, including our guest speaker, Major General David Mize (Ret) and his wife Jane.

This year's banquet was attended by 200 members and guests. Our Banquet Ceremony commenced with the posting of the national and USMC colors by a Color Guard from the 4th Marine Aircraft Wing. The ceremony invocation was given by Pastor Bonnie Goodwin, spouse of Sgt. Ken Goodwin (H&S 1965-1966). MGen. Mize gave well-received remarks about beginning his professional career as a platoon commander with Echo Company and how the lessons learned as a combat leader served as a foundation for him as he assumed more responsibilities with subsequent promotions, culminating in the command of the 4th Marine Division.

During our banquet, MGen. Mize awarded a delayed award of the Navy Commendation Medal to Sergeant Thomas (Blue Boy) Ray who was recognized for his actions while serving as an S-2 Scout with 2/1 (1969 - 1970). Sgt. Ray's personnel records were also updated, through the assistance of Master Gunnery Sergeant Frank Odzimowski, to correctly authorize the Combat Action Ribbon for Sgt. Ray. As customary, the Reunion Banquet ended with a lively raffle of Marine-related items and a healthy infusion of humor from our auctioneer, Treasurer Mario Sagastume.

As the Trustees of VV 2/1 review this year's reunion, the most critical question we have is whether or not the membership had an enjoyable time. Based on the comments by many members and the positive parting comments, it looks like that question has been affirmatively answered.

The Trustees of VV 2/1 look forward to our next reunion in San Diego, California in November. Hope as many of you as possible can make the trip. It is always good seeing our members and to be in their company.

President Philip D. Leslie – Called the assembled sixty members to order and notified them that Master Gunnery Sergeant Frank Odzimowski (Ret) has been appointed the Association's Sergeant-at-Arms and Parliamentarian.

The Annual Membership Meeting of the Vietnam Veterans of the 2<sup>nd</sup> Battalion 1<sup>st</sup> Marines (VV 2/1 or Association) was **Called to Order** by MGySgt. Odzimowski, following which, he led the assembly in the **Pledge of Allegiance**.

In attendance were all the Officers and Trustees of VV 2/1 and sixty Association members.

Award Ceremony - Recognition was made public by MGySgt. Odzimowski that former Sgt. Thomas (Blue) Ray [H&S S-2 Scout – 69-70] rates the Combat Action Ribbon for his Vietnam service in 1969 and 1970. A corrected personnel-record oversight now gives overdue authorization for Sgt. Ray to wear the ribbon. The order was publically read by MGySgt. Odzimowski to the assembly. Sgt. Ray was also awarded the Navy Commendation Medal at the banquet by MGen. Mize following a several-decade delay due to lost supporting documentation.

**President Philip D. Leslie – Opening Comments.** Phil said that he and the Board are glad to see everyone, especially the new attendees. He gave a brief overview of the site selection process and the importance of parking and free breakfast held in selecting a hotel. Phil then gave an update on VV 2/1 – we're in good shape and always looking to serve the members better.

Vice President Lansdale B. Williams – Comments. Dale welcomed the membership. He stated that he is not seeking reelection as vice president or as a trustee, but he will stay involved with the brick program. Dale thanked the members for their support during his time in office and looks forward to being with his Fox Company brothers.

Treasurer Mario A. Sagastume gave the Treasurer's Report. VV 2/1 is solvent with a small cash reserve in a dedicated VV 2/1 bank account. VV 2/1 uses September 30th as its fiscal year-end date. The Association will make its annual IRS filing on a Form 990 EZ Report. Any member is welcome to look at the books of the Association upon request. A motion was made and seconded to accept the Secretary's Report. The motion was unanimously accepted by the membership.

**Secretary Timothy Dunn gave the Secretary's Report**. The report was the 2017 Membership Meeting Minutes. Dunn reminded the membership that the minutes will be on the Association's web site for all to view. The 2017 Membership Meeting Minutes were accepted by proclamation by the membership.

Webmaster Vin Burdziuk – Communications Report. Vin gave an overview of our web site visits (649,588) and the ability to post photographs, citations, stories, etc. on our web site. Vin also noted that the "Get Well" card program started by Phil Odom is still going strong. Send information along about ill or infirm members, as well as members who have passed. Total cards sent this year was 34.

Membership/Registration – Timothy Dunn and Doc Stein. Tim and Doc reminded the membership about the importance of keeping the Association informed about address/contact changes in order to keep our membership abreast of upcoming events. Members were asked to return the membership info form by the end of the reunion.

Hospitality Room – Jesse Tipton and Jose Perez. Jesse thanked the assembly for their care of the Hospitality Room. Jesse also solicited requests on the variety/selections of beverages and snacks. He will consider all requests and suggestions to keep the Hospitality Room friendly and enjoyable.

Jose has monitored the beer and wine consumption and successfully kept the products in stock. Please send him suggestions of beer for future events.

Silent Recognition – A moment of silence was held at 1100 hours in recognition of the 100 Year Anniversary of Armistices Day.

## **Annual Membership Meeting**

As required by VV 2/1's By-Laws, elections must be held annually for expiring terms or resignations of officers and trustees. Candidates serve for various lengths of office and are expected to fund their own expenses while on Association business. The election results are:

Vice President – Dale Williams decided to "retire" after long service as vice president. Tim Dunn (Hotel 66) was elected VV 2/1's vice president.

Secretary - Tony Kilroy (Fox 69-70) was elected VV 2/1's secretary.

All candidates received unanimous votes of approval from the members.

Trustee – An interim Trustee position was vacated when Wayne Thornton submitted his board resignation. Following By-Law guidance, Vin Burdziuk (H&S 65) succeeded Wayne as a Trustee.

We veterans of VV 2/1 have reached the middle of the battalion's mid-point of its fifty-year deployment to Vietnam (1965 - 1971). For many of us, it seems like fifty years ago, yesterday. Many of those experiences, stories, remembrances, thoughts, feelings may feel as if they are still fresh in our minds/

consciousness (and they are!), but time is not on our side.

In earlier years, we produced two volumes of our story We Remember, to very favorable acclaim. But it has been a while. During that time, we have had other members of the battalion become active members of VV 2/1. Surely, they must have stories to record. Plus, those who have previously submitted stories for publication may have other stories to contribute to the literature of our battalion's deployment to Vietnam.

Is it time for us to compose a third volume of our story? We are a dwindling group, as we are aware. I remember remarks by Gen. Anthony Zinni a few years ago that the majority of those who served in the Vietnam War have already passed. Notwithstanding the cumulative number, we are at the age (and often on-set condition) where our numbers are shrinking at an accelerated rate.


