## 2021 Reunion Fairfax, Virginia May 18<sup>th</sup> to 24<sup>th</sup>

As we noted in past business meetings, VV 2/1 planned its 2021 reunion for the Washington, DC Metro area (as required by our By-Laws every four years). This reunion was scheduled for May in anticipation of attending the Evening Parade at 8<sup>th</sup> & I on Friday May 21, 2021 (weather and Marine Barrack's schedules permitting).

Our hotel consultant requested quotes from available hotels in the area and presented her finding to the Board of Trustees for consideration. The Hyatt Regency Fairfax was a finalist on the list, and following a virtual Zoom tour, the Trustees signed a contract with this hotel.

The hotel has agreed to:

Free parking

Beer, wine and snacks for our Hospitality Room at not charge (other hotels are now requiring groups to purchase from the hotel)

Breakfast discounted to \$15/person - Reunion ID Badge required

Block Room rates \$139.00/night

"Shoulder Dates" for Block Room rates – three days prior and three days following our contracted dates

Ball Room capacity to accommodate our banquet

Hotel reservation information will be published in a separate notice.

The hotel is a 20 - 25 minute drive to the Washington, DC Mall (Vietnam Memorial Wall) and close to many other Northern Virginia attractions. Dining and shopping venues are close by the hotel (5 minute drive or less).

#### V V 2/1 Getting Out of the Donation Business

The Association is getting out of the charitable donation business and using our remaining funds to directly benefit the membership during our reunions. Over the past decade, VV 2/1 has donated a third of its assets to various charitable entities without seeing significant contributions from our members or outside entities to support these charitable donations. Our bank account will not be able to sustain future contributions without donations to VV 2/1.

As an IRS-registered 501(c)(3) charitable organization, donations to VV 2/1 are tax deductible. The same IRS Code does not compel VV 2/1 to donate any of its funds to other organizations. VV 2/1's tax exempt status is primarily for the benefit of our members. VV 2/1 does not realize any tax benefits when it makes charitable contributions to outside organizations. Those contributions, as well-intended as they may be, only decrease our bank account and provide small contributions to the recipient organizations.

The Board of Trustees will use the remaining funds in our bank account to directly benefit our members during our annual reunions by subsidizing various functions and excursions, thus reducing those costs to the membership.

Presently, VV 2/1 makes an annual donation to a member-related organization, which was approved by a vote of the membership during the last Washington, DC reunion. We will continue this donation until we vote on the matter at the next membership business meeting. New requests for donations will not be entertained.

Membership in our Association is shrinking annually, so are the donations to VV 2/1. While we are still able to meet at annual reunions, let us spend the money we have on ourselves. Those members who seek donations to various causes and organizations are welcome to make solicitation presentations to the membership at our reunion business meetings. Members who wish to donate to these organizations may do so directly.

## **Protect Yourself From Identity Theft and Financial Fraud**

Recently one of our members was the victim of identity theft and financial fraud. As a former federal financial regulator and still active Certified Fraud Examiner, I wanted to share some tips about protecting yourself from identity theft and financial fraud.

Financial fraud is a result of someone using your confidential personal information to gain unauthorized access to your accounts or assets. <u>Your identity was stolen for fraudulent use</u>. The membership of VV 2/1 are of the age where we have accumulated financial assets (investments, savings, retirement accounts) and are "targets" for the fraudsters because of those accumulated assets.

Due to the wide use of computers, much of this fraudulent activity is conducted on-line in combination with suspicious or felonious telephone solicitations. The "attacks" are constant and on-going, even without our active use of the computer. Recently I was locked out of a bank account I own because of an unauthorized on-line access attempt. Access was denied when the fraudsters could not answer the security questions. I had to reset my passwords and security questions once I was identified as the authorized account holder.

#### • Basic Protective Steps to Follow:

(1)Do not engage in verbal or written solicitations from unknow parties.

(2)Never disclose confidential personal information (Social Security Numbers, account numbers, license numbers, etc.) in telephone conversations or email communications.

- (3)Do not respond to telephone calls or emails that claim to be from government agencies
  - (IRS, Social Security Administration, law enforcement or courts).
- (4)Government agencies do not call you on the telephone. The agencies send letters on official stationery when they want to communicate with you.
- (5)Reconcile (check and verify) your financial statements regularly and look for discrepancies. If you find a discrepancy, call the issuing company immediately.
- (6)Report all suspected and/or actual financial theft to the local police (record an incident report), the financial institution where the account is held, and any regulatory authority.
- (7)Change your computer access passwords periodically and use passwords that are more complex than simple (Stay away from 1, 2, 3, 4, 5 or A, B, C, D types of passwords).

Although you may have good protections in place, there is no guarantee that you will not be victimized. The fraudsters are exceptionally good at what they do. Finally, the unfortunate reality is that once the fraudsters get your money it is quickly gone. Your recourse is to establish that the financial institution where your account is did not follow their security controls and seek reimbursement. The process for reimbursement is lengthy and time consuming. Stay diligent in protecting your identity and finances. Report all suspicious activities to the authorities and keep a record of those incidents and reports.
