2. ENEMY, WEATHER AND TERRAIN

a. General. During the month of November enemy activity decreased in this Battalion's TAOR. Intelligence sources indicated that the enemy may have been preparing for a concentrated attack on Da Nang and outlying military installations. While the enemy has been building up in this area the use of mines and surprise firing devices have declined.

The Volunteer Information Program was emphasized this month and the results were the greatest amount of ordnance ever turned into this Battalion. On at least one occasion the enemy has booby trapped ordnance and left it for the local children to turn it in to the motorized patrol.

A detachment of 3rdCIT working with the 2nd Battalion has captured the majority of the Viet-Cong infrastructure in the outlying villages. Interrogation has revealed that over 100 Viet-Cong have been killed in the vicinity of Viem Dong (BT 095695) during the past two months. CIT and IIT continued to up date the blacklist utilizing captured documents and intelligence sources.

d. Weather and Terrain

(1) Weather. Partial typhoon conditions prevailed throughout the month of November. Trafficability and visibility remained good in all areas except lowlands adjacent to Vinh Dien river which were subject to flooding. Although the monsoon season is well under way the monsoon may be termed light to moderate.

(2) Terrain. Terrain in the 2nd Battalion, 1st Marines TAOR makes operations difficult due to the fact that much of the area is inundated.

3. ORGANIZATION AND OPERATIONS

a. For the entire reporting period the Battalion was tasked with the following primary missions: To conduct unilateral, joint and combined offensive operations within the assigned TAOR to locate and destroy enemy bases which pose the greatest threat to the GVN control of important population and economic centers and to the security of friendly military installations, and secondly to deploy forces throughout the assigned TAOR to provide defense of the Da Nang vital area and military complex, with emphasis on routes of approach to probable rocket/mortar launch positions to include waterways.

b. Offensive operations in the Battalion TAOR consisted largely of day and night small unit combat patrols and night ambush patrols. In addition, three search and clear operations and two cordon and search operations were conducted. Company D, 1st Battalion, 1st Marines was chopped to the 2nd Battalion, 1st Marines for a one day, helicopter-borne search and clear mission in the Riviera Area. Road security was maintained by the use of engineer sweep teams, day time rat patrols, night time roving patrols, observation towers and radar devices.

c. Contact for the reporting period was light and consisted of daily harassment by VC employing surprise firing devices and small unit sniper teams. However, there was a significant decrease in the number of mining incidents when compared to past months. There were two incidents of enemy shelling the 2nd Battalion, 1st Marines CP. The first consisted of five 82mm mortar rounds resulting in five WLI's (minor). The second incident consisted of eight 82mm mortar rounds and resulted in the destruction of one M-35 truck.

4. AIR SUPPORT

a. Helicopters of the 1st Marine Aircraft Wing flew 25 medevac sorties in support of the 2nd Battalion, 1st Marines. That total represents 11 emergency, six priority and three routine Marine casualties, seven civilians, two ARVN and one VC/NVA casualty. Non-battle casualties consisted of one emergency, two priority and two routine lifts.

b. Five visual reconnaissance flights were made for a total of eight sorties and air observers were used on 13 occasions by commanders in the field.

c. Six Huey gunships provided close air support for this Battalion.

d. Six helicopter troop lifts were conducted, totalling fifty sorties. Two passenger pickup flights were made. Fifteen resupply flights were flown for a total of twenty-eight sorties.

e. Three OV-10 air strikes were also flown for this Battalion.

5. ARTILLERY AND FIRE SUPPORT

a. From 1 to 30 November 1968, fire support liaison was effected by personnel of Battery "B", 1st Battalion, 11th Marines. During this period two men, Lt Jim LUCORN, Forward Observer for Company G, and Lance Corporal Ronald MAGNESS, Radio Operator for Company G, became casualties.

b. One officer and three enlisted personnel reported aboard during the month of November. One officer and one enlisted personnel were medevaced, one enlisted personnel rotated back to the battery. Our present strength stands at four officers and fourteen enlisted.

c. The 1st Battalion, 11th Marines remained in support during the entire month. During the month approximately 2800 artillery rounds were fired in support. The artillery B&I program was supplemented by 1250 HE, 175 WP and 1427 illumination rounds fired by the 81mm mortars.

d. Battery "B", 1st Battalion, 11th Marines held a training program for 34 members of the 64th ARVN Artillery Battalion. The training ran in duration from 29 October to 6 November 1968.

6. TRAINING

a. During November 1968, training consisted of normal orientation and F&M firing for new personnel, formal school training and company/platoon level classes on weapons safety procedures. M-16E-1 rifle, M-60 machine gun, M-79 grenade launcher, M-72 LAW, 60mm mortar, 81mm mortar, map and compass reading and patrolling. The Battalion Motor Transport School was continued, emphasizing drivers training and first echelon maintenance. Battalion established a three day school for Battlefield Surveillance Radar (AN/PPS-6). Approximately 12 hours of instruction was held on surprise firing devices.

b. New replacements received orientation on Vietnamese people, land mines, surprise firing devices, enemy tactics, handling POW's, Kit Carson employment, Rules of Engagement, MACV Rules, Supporting Arms, Weapons Safety, Civil Affairs/Civic Action/ Psywar, Narcotics, Prostitution and First Aid. All new personnel fired individual weapons for familiarization and zeroing at 1000 inch range.

7. LOGISTICS AND SUPPLY

a. Logistics

(1) The Battalion is short of boots and repair parts, available main gear has been distributed to Battalion.

(2) During the month a repair team from FSR repaired office equipment for the battalion. However, most of the typewriters are old and should be replaced with new ones.

(3) Replacement of code II equipment is too slow and causes a hindrance to the mission of this unit.

b. Motor Transport

(1) Two personnel carriers, M37B1, are in third echelon for repair.

(2) Four M416 trailers are on order; one in second echelon for repair.

(3) Four truck platform utility are in for third echelon repair, eight on second echelon and four on order.

(4) Three truck utility M151 are on third echelon repair.

(5) There is a shortage of personnel in the 3516 and 3531 field at the present time.

c. Roads

(1) The roads in this area are serviceable during dry weather. However during wet weather the roads are deeply rutted and often washed out causing excessive wear to vehicles.

d. Supply

(1) The supply situation is improving with the support from FLC. However, the battalion is still lacking in boots and repair parts. Most of the monsoon rain gear has been distributed and ponchos are still available.

(2) During the month T/E deficiencies were placed on order for the companies. The allowance lists have been updated.

(3) The personnel situation is still critical with no relief in sight.

e. Fiscal Obligation

(1) Obligation during the month of November for SFA items were \$95,720.04. Funds for ASI items were \$18,754.08.

8. CIVIC ACTION/CIVIL AFFAIR

During the month of November the activities of this section were directed towards making liaison with the villages in our Battalion TAOR. This liaison effort was also used to obtain all possible information from the villagers concerning the sudden increase in VC activities in our area and the decreased cooperation seen in areas of increased VC activities. Armed Propaganda Teams have been used in a pacification effort to attempt to convey the message to the villagers that we wish to do all we can to aid them, but cannot do so until they show us more interest and cooperation.

Several Solatium Payments were made this month by the Battalion S-5 Officer.

Battalion S-5 Staff NCO returned from Vietnamese Language School at CIG-2.

Daily medcaps were held at the Battalion CP. Soap was distributed at the medcaps. Several thousand pounds of rice was received by this section this month, part of which was distributed to the villagers and the remainder was taken to Division G-5.

9. COMMUNICATIONS

Inventory and requisition of all existing shortages has been completed. Engineers began construction on a 20'x32' communication bunker intended to house the message center, AN/PCC-1 radio relay and the Battalion switchboard. Three more AS-2236/GRC antennas were force fed to the Battalion bringing the total to six.

Guard switchboard was relocated to COC bunker. Cabling and police of all wire in the cantonment was initiated.

The message center handled 1159 incoming messages and transmitted 73 messages.

Fifteen AN/PRC-25 radios were repaired locally and thirteen were evacuated to FSR. The radar technicians concluded a four day course of instruction on the operation and maintenance of the AN/PPS-6 radar set to fourteen members of the Battalion.

10. MEDICAL

- a. The Battalion Aid Station treated 807 sick call patients during the month of November.
- b. There were 7 USMC KIA due to hostile action. There were 26 MIA's.
- c. Totally, there were 25 cases of Upper Respiratory Infection, 14 cases of diarrhea, 59 foot disorders, 173 skin disorders and 608 dental patients seen. There were 521 patients seen for treatments not listed.
- d. A total of 1361 immunizations were given to this battalion during November.
- e. A total of 1194 Vietnamese civilians were treated on medcap.

11. CHAPLAIN

a. The Battalion Chaplain conducted eight Sunday Protestant Divine Services with 152 attending. Chaplain O'Neil (1st Engr Bn) conducted four Sunday Roman Catholic Divine Services with 84 attending. Chaplain O'Neil conducted one weekly Roman Catholic Divine Service with 21 attending.

b. Chaplain Pepper conducted two weekday Protestant Divine Services at the Mortar Belt position, with 75 attending. There were eight Protestant Bible Study classes with 55 attending. There were 22 weekday Prayer Meetings with 109 attending.

c. A Battalion Memorial Service was held on 3 November 1968, with 205 attending. The Battalion Chaplain visited 43 men in the hospitals, and made three brig calls, visiting three men. There were four Red Cross cases, six MARS priority calls, and 84 counselling cases.

12. PSYCHOLOGICAL OPERATIONS

During this month, November, an Armed Propaganda Team was used in our TAOR, in Cam Sa (1) hamlet, Thanh Minh Village.

A leaflet drop was made in our Battalion TAOR, concerning the reporting of information on VC rice collectors; the leaflet is leaflet #7-242-68.

Mine Reward Leaflets were distributed to the villagers during daily medcap at the Battalion CP.

A PsyOps Team was used to record on film, an incident which occurred in the hamlet of Nui Kim Son, in which a Special Forces Vehicle was destroyed and several civilians were wounded, and an RVN soldier was killed by VC. This film is being made into a leaflet, for future leaflet drops in our TAOR.

SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTSORGANIZATION AND OPERATIONS**UNCLASSIFIED**

- 3Nov68 - At 030730H Company G, conducted a search and clear operation in the northern portion of the ROK area of operations (BT 091633). While searching, the unit uncovered an enemy cache consisting of eight 122mm rockets, 5000 pounds of rice and 20 large, heavily reinforced living bunkers.
- 4Nov68 - At 040700H Company G, while continuing a search and clear operation in the northern portion of the ROK area of operations (BT 093633) discovered 4000 pounds of rice, 15 large reinforced living bunkers, two 82mm mortar fuzes, one chicom grenade, three 155mm duds, two 105mm duds and AK-47 ammunition.
- 6Nov68 - At 060900H Company G, while continuing a search and clear operation in the vicinity of (BT 075634), located eight large living bunkers containing approximately 2900 pounds of rice.
- 15Nov68 - At 150800H Company G, supported by one platoon of National Police Field Forces and one IIT team, conducted a cordon and search of An Tra (1) at (BT 078695). The Marines cordoned the village and the Police Field Forces swept the village at first light. No enemy caches were discovered. Six personnel were detained for further interrogation.
- 16Nov68 - At 161100H Company G, supported by IIT conducted a cordon and search of Ngan Cau (1) at (BT 057657). Five personnel were detained for further interrogation.
- 16Nov68 - At 160630H Company G, conducted a search and clear in the southern portion of the Desert area of operation at (BT 047647). Light contact was encountered. During the sweep one bunker and one AK-50 were found. Six detainees were apprehended.
- 16Nov68 - At 181730H Company D, 1st Battalion, 1st Marines, became OPCON to 2nd Battalion for a one day helicopter borne search and clear operation of Tra Lo (BT 084683).
- 19Nov68 - At 190900H Company G was chopped to 1st Battalion, 1st Marines.
- 19Nov68 - At 191000H Company D, while conducting a search and clear operation of Tra Lo (BT 086483) found one concrete bunker, and one dirt bunker. The bunkers contained one browning automatic

rifle, one M-1, two loaded carbine magazines, two 175mm nose cones, one B-40 charge, one illumination grenade, 1900 AK-47 rounds, two M-79 rounds and eight M-16 magazines.

- 20Nov68 - At 200016H, 2nd Battalion OP's observed approximately 10 to 12 rockets fired from (BT 047689). Crows Nest and Alpha-6 brought the enemy under fire with 106mm recoilless rifle fire. Artillery, 81mm mortars and gunship missions were called on site. A Foxtrot unit was dispatched to the site and found 12 launching sites, electrical firing equipment and two complete 122mm rockets.
- 20Nov68 - At 200030H, 2nd Battalion CP received five 82mm mortar rounds from (BT 068637) resulting in five WIA. An 81mm mortar mission was called on the enemy site silencing the enemy mortars.
- 20Nov68 - At 200030H, Company H observed approximately 10 to 15 82mm mortar rounds fired from (BT 059710). Crows Nest and Alpha-6 brought enemy under fire and Company H fired a 60mm mortar mission, silencing the enemy mortars.
- 22Nov68 - At 221145H, Company F was lead to a VC rice cache by a Vietnamese informer at (BT 097634). One thousand pounds of rice was found.
- 24Nov68 - At 242323H, 2nd Battalion units reported eight rockets fired from (BT 067680). An 81mm mortar, 106mm recoilless rifle from Crows Nest and gunship missions were called in on the enemy site.
- 25Nov68 - At 252315H, an H&S patrol on a mission to apprehend VC cadre at (BT 075646), received small arms fire and 60mm mortar fire from approximately eight to ten VC resulting in two UMMC WIA. Unit returned fire resulting in two VC KIA and one VC suspect detained. Checked area with negative assessment.
- 25Nov68 - At 250116H, 2nd Battalion CP observed nine enemy rockets fired from (BT 079643). An 81mm mortar and 105mm artillery mission were called on the enemy position. Checked area with negative assessment.
- 25Nov68 - At 250125H, 2nd Battalion CP received eight 82mm mortar rounds from (BT 064648) resulting in one M-35 truck destroyed. Artillery and mortar fire was directed on the enemy positions.
