All the help we can do is appreciated to get rid of this unfair payment schedule. Reference Senate Bill S66 and House Bill HR 303.

Senator or Congressman (Name);

I am seeking your support for HR303 refiled from the 114thCongress.

Many retired military with Service Connected Disability (SCD) below 50%, current law stipulates that their retirement pay be reduced dollar for dollar by the amount of their current VA awarded disability compensation. The program, as it stands, only impacts retired military veterans who have earned a retirement pension for 20 years or more of military service and have a (SCD).

Currently within the Veterans Affairs there is a Compensation Program called Concurrent Retirement and Disability Pay (CRDP). This requires that a veteran's retirement pay be reduced by the amount awarded for SCD. Congress and the VA decided years ago that it was unfair to continue to treat retirees with SCD in this manner and instituted an amended CRDP removing the offset requirement for any retiree witha SCD of 50% and over. Congress promised to address those with 40% and less at a later date, but wanted to correct the injustice for those with more serious disabilities first. The phase in of CRDPt address the disability offset was completed in January 2014. Sufficient time has gone by to make the corrections and honor the promise to include all retirees, but the bill, HR 303, has not moved forward.

I thank you for your time and hope you will press support in any way you can for HR303.
