Abortion Clinic in Alabama Closed After Botched Abortions

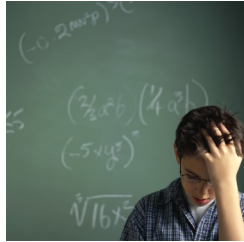
An incident that sent two abortion patients to the hospital from a



Birmingham abortion clinic in January has resulted in the state health department in Alabama ordering the closing of the abortion clinic in question.

As LifeNews reported, the health department issued a scathing 76-page deficiency report written by the Alabama Department of Public Health that details dangerous and deceptive practices that continue to endanger the health and safety of women.

The report found violations in nine categories after a complaint lodged by a pro-life activist prompted a health inspection of New Woman All Women clinic owned and operated by Diane Derzis, who was once dubbed by Alabama legislators as the Abortion Queen. Derzis owns abortion clinics in Alabama, Georgia, Mississippi, and Tennessee.
