The Down Syndrome Association of Miami shares about the changes Valentina has already made in her parents’ lives.

Valentina, daughter of the TV Host and Producer Ceceliz, and Juan Fernando, was born in September with Down Syndrome, which propelled her parents to create awareness of the wonderful lessons and experiences that she brings, focusing on the daily inspirations rather than on the challenges that the condition may entail. ‘They teach us

much more than we will ever teach them,' notes Ceceliz.

### **Planned Parenthood May Face Family's Lawsuit Over Abortion Death**

### **Assisted Suicide Backers Confident They'll Win in Massachusetts**

Massachusetts is the latest battleground over euthanasia with an initiative on the ballot in November to adopt a statute similar to those in Oregon and Washington, which allow physicians to prescribe suicide for their patients.

As in Oregon and Washington, the Massachusetts proposal states assisted suicide would be legal for residents of the state in cases where a doctor has determined the patient has less than six months to live. However, the examples of the two Western states have shown that those safeguards do not work.

Robin Loughman, R.N., Chairwoman of the Massachusetts Alliance Against Doctor-Prescribed Suicide (MAADPS), said in a press release, “a prognosis of six months to live is inexact at best. This question gives people the means to commit suicide. The doctor has no obligation to be sure the person is competent, not depressed, or not under pressure. The doctor is required to falsify the death certificate by stating the cause of death to be the “underlying condition” rather than the suicide that occurred.”

“We’re confident ... that we’ll be successful in November,” said Stephen Crawford, communications director of the pro-assisted suicide “Dignity 2012” campaign. Media coverage of the debate has been decidedly in favor of the proposal. According to Loughman, the press has used the word “medication,” which should cure, instead of the descriptive, “lethal dose.”

In June, a poll by the Western New England University Polling Institute found sixty percent of Bay State voters in favor of the ballot measure. However, polling on ballot questions are not as

straightforward as polling on candidates running for office, a point also made by the director of the Polling Institute at Western New England University.

“Polling on ballot questions is tricky because responses can be highly sensitive to question wording,” said Tim Vercellotti, associate professor of political science and director of the Polling Institute at Western New England University. “The actual questions that the voters see on the ballot tend to be longer and more complicated. Our questions attempt to get to the essence of each issue.”

The survey asked voters whether they supported or opposed “allowing people who are dying to legally obtain medication that they could use to end their lives,” according to Vercellotti.

If presented with the reality of legalized assisted suicide, it remains to be seen whether voters would go along with the proposal. According to the Robert Powell Center for Medical Ethics at the National Right to Life Committee, the so-called safeguards do not work. In addition, the legalization of assisted suicide brings grave implications for the medical field by transforming doctors from healers into killers.

**War on Women: Planned Parenthood Denies Info on Abortion Risks**

South Dakota is doing everything it can to let downtrodden pregnant women know there are better, healthier options than abortion. In March 2011, South Dakota's Gov. Dennis Daugaard signed the Abortion Informed Consent Statute into law. Although the constitutionality of the law was immediately challenged, and Planned Parenthood recoiled at the thought of mothers being informed of all the dangers abortion poses for them (in addition to the child), the Eighth Circuit Court of Appeals has ruled that all major provisions of the law can stand. Generally speaking, this means that women seeking an abortion in South Dakota's only abortion clinic will be informed beforehand that "an abortion terminates the life of a whole, separate, unique, living human being," that the mother's "relationship with that second human being enjoys protection under the Constitution of the United States and the Laws of South Dakota," that relationship and all rights attached to it will be terminated, and the medical and psychological risks abortion subjects mother to, including "at increased risk for...suicide." What South Dakota lawmakers understand is that a woman who chooses to have an abortion needs to be aware of the incredibly grave

consequences associated with that decision. Thus the goal with the Abortion Informed Consent Statute is not only to reduce the number of children aborted, but also the number of mothers who have abortions and, as the Supreme Court itself has recognized, "come to regret that decision" and, tragically, seek to harm themselves because of that regret.

In other words, while the affects abortion has on preborn children are literally heart-stopping, the repercussions in the lives of women who have the abortions are sometimes no less final. Since the late 1950s, studies have linked abortion to breast cancer, depression, mental illness, and suicide. Yet because of the money flowing in and out of organizations like Planned Parenthood, these studies have been suppressed or dismissed for purely political reasons. But too many people now know the truth about the horrific consequences of abortion—and more and more people are learning this truth each day. South Dakota has decided enough is enough. Therefore, from this point forward, mothers who want to go to the Planned Parenthood-operated clinic in that state will first be told not only what will be happening to their preborn child, but what they are potentially doing to themselves
