**Democrats Defeat Cruz
Amendment to Repeal Pro-
Abortion Obamacare**

On the third anniversary of the passage of President Obama's controversial pro-abortion health care bill, Democrats defeated an amendment to repeal Obamacare.

Sen Ted Cruz, a pro-life Republican from Texas, filed an amendment to the budget bill to establish a deficit-neutral reserve fund to provide for the repeal of the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act of 2010 and to encourage patient-centered reforms to improve health outcomes and reduce health care costs.



But Democrats balked and defeated the measure 54-45, with Republicans voting for the amendment and Democrats in opposition.

“Tomorrow is the three-year anniversary of the passage of Obamacare,” Cruz said on the floor before the vote.

“Obamacare is hurting young people. It’s hurting seniors. It’s hurting Hispanics. It’s hurting African-Americans. It’s hurting single moms. It’s hurting the economy. It should

be repealed.”

“ObamaCare itself includes some 20 tax increases over \$1 trillion,” Cruz said. “Many of those tax increases fall of the middle class.”

Until Democrats no longer control the Senate and White House, repeal of Obamacare will remain limited to the House.

Unhappy that the Supreme Court didn’t overturn the Obamacare law that includes taxpayer funding of abortions and rationing concerns, leading pro-life groups have urged members of Congress to vote to repeal the law wholesale.

In a letter to members of Congress previously, the National Right to Life Committee said it is concerned about both abortion funding and health care rationing.

“NRLC vigorously opposed enactment of the Obamacare law in 2009-2010, because of its multiple provisions

authorizing federal subsidies for abortion insurance, multiple provisions allowing abortion-expansive federal mandates, and multiple provisions that will place unacceptable limits on the right of vulnerable Americans to use their own money, if they choose, to obtain both health care and health insurance less likely to deny needed health care,” the pro-life group explained.

It continued: “Since its inception, the pro-life movement has been as concerned with protecting the lives of older people and people with disabilities from euthanasia, including the involuntary denial of treatment, food, and fluids necessary to prevent death, as it has been dedicated to protecting unborn children from abortion.”

Meanwhile, the Susan B. Anthony List has urged members to vote for repeal as well and focused on abortion funding.

“Obamacare creates heavy

federal subsidies – your tax dollars – to help pay for insurance plans that cover elective abortion,” it said in an action alert to its membership. “Millions of Americans will be enrolled – many unknowingly – in health care plans that include elective abortion coverage.”

“These plans will charge enrollees, regardless of age and gender, a minimum of \$1 per month – an “abortion surcharge” that will go into an abortion slush fund. Under a rule recently issued by Health and Human Services (HHS), the existence of the “abortion surcharge” only needs to be disclosed once – in the fine print – during the enrollment process,” SBA continued. “This surcharge is included without itemization in the monthly premium and is never disclosed again.

The Supreme Court incorrectly ruled that Obamacare is constitutional, pro-life groups said in response to the decision. They are pointing out that the need is greater now than ever to defeat pro-abortion President Barack

Obama and elect a pro-life Senate that will join the House in repealing the legislation.

Under the enacted law, federal tax-based subsidies will begin in 2014 to subsidize millions of private insurance plans that will cover abortion-on-demand, including some plans (“multi-state plans”) that will be administered by the federal government. Under another provision of the law, the federal government could even order many plans that do not receive federal subsidies to cover abortion as a “preventive” service. The law also created an array of other mechanisms and funding pipelines by which access to and subsidies for abortion can be expanded if President Obama wins a second term.

Black Pro-Lifers: Race No Defense to Gosnell Snipping Babies’ Necks

Black pro-life leaders are upset that the attorney for Kermit Gosnell is using his race, as an African-American, as a defense for the abortion practitioner against multiple charges that he killed babies by “snipping”

their necks and spinal cords.

They say they are upset the defense attorney for the Philadelphia abortionist, whose abortion clinic earned the title “Gosnell’s House of Horrors,” has tried to reduce Gosnell’s charges to “prosecutorial lynching.”



In his opening arguments, defense lawyer Jack McMahon called the case “elitist” and “racist,” and charged the trial is coming from prosecutors trying to “put Mayo clinic standards into a West Philadelphia clinic.”

Dr. Alveda King, Director of African American Outreach for Priests for Life, tells LifeNews this strategy is an insult to the babies he slaughtered, the women he maimed and killed, the African Community at large and the human race. She says it is Gosnell who is elitist and definitely racist.

“Don’t Black women and babies deserve Mayo Clinic standards?” said Dr. Alveda King, Director of African American Outreach for Priests for Life. You sir, are being elitist and racist to suggest that we do not. We reject the notion that the black and brown women Gosnell preyed upon deserved less. Your tactics are shameful, outrageous and an affront in the face of God,” the niece of Dr. Martin Luther King, Jr. said.

Day Gardner of the National Black Prolife Coalition also disagrees with Gosnell’s race-based defense.

“Throughout the Holocaust Josef Mengele aka ‘the angel of death’ delighted in killing young children in the most atrocious and gruesome experiments — all in the name of science,” she said.

Gardner added: “Kermit Gosnell, is the Black community’s Mengele because he especially preyed on children of his own race who were fully born — totally free to experience the life and liberty

that we are all promised in America. Yet, at that moment of new life — the child in warm hands, breathing air, seeing first light, may have also seen the face of his or her executioner. The only factor of ‘race’ is that Gosnell killed these children because he could. He thought no one would really care — after all, it’s just one more Black child — dead in Philadelphia.”

Catherine Davis, Founder and President of the Restoration Project and another black pro-life advocate, chimed in as well.

“Selling out the Black community in the name of abortion rights is unconscionable,” she said. “But, Gosnell’s attorney has taken this betrayal to a new low by claiming Gosnell should not be prosecuted because he is black. While “women kept being referred to and coming to his clinic because they could get what they needed at the right price.

Black pro-life activist Walter Hoye is also upset and said

Gosnell made money on the desperation and despair of women from his own community — something akin to how the Klu Klux Klan treated black women.

The African-American pro-lifers are spearheading investigations, calling for enforcement of life saving laws for women and children, and are advocating information campaigns as to the harmful impact of eugenics and genocide in the Black community.

New Mobile App Has Amazing Pictures of Unborn Babies, Helps Women

I recently discovered a mobile app on my Smartphone created by the people at WebMD, a website run by doctors that gives medical and health information. It is still another example of how technology is rendering standard pro-abortion arguments utterly obsolete.



The app is called “WebMD Pregnancy,” and it is described as “a free pregnancy app...that delivers trusted health information to expectant moms as well as fun features and tools. Whenever. Wherever. Online or offline.”

The app provides information based on individual pregnancy schedules including doctor-reviewed articles, videos, informative slide shows, and a calendar to keep track of your baby’s development and upcoming doctor’s appointments.

Being a WebMD product, it also comes with features to help keep mother and baby healthy. There are check lists of things to ask your doctor throughout the different stages of pregnancy, appointment reminders, and a space to record things your

doctor said or suggested to you at your appointments.

There are even more personal features to the app including a journal to record the events of your pregnancy and social sharing apps to keep your close ones informed on you and your baby’s progress.

WebMD even features a follow-up app called WebMD Baby to help you continue keeping your little one healthy.

“WebMD Pregnancy” is built for an age where unborn babies can have their very own Facebook pages, and where being pregnant can mean remembering to incessantly email friends and family members with every new development.

As a mobile app that not only refers to the unborn from the first moments of its life as a “baby,” but also treats this baby as a patient as a living human being who requires care, I see this as yet another example of how technology threatens to leave the pro-abortion argument in the dust.

40 DAYS OF MOCKERY



There are a number of pro-
abortion backlash efforts that
have adopted the “40 days”
theme. The worst of the lot is
jointly sponsored by “Clergy for
Choice” and the Planned
Parenthood affiliate in Eureka,
California.

This effort, “40 Days of Prayer
to Keep Abortion Safe and
Legal,” is really a mockery of
40 Days for Life – and frankly,
of God. They use a collection
of 40 daily prayer intentions –
sounds familiar, doesn’t it?

But listen to some of the
“Clergy for Choice” intentions:

- Day 5: Today we pray for
medical students who want
to include abortion care in
their practice.
- Day 18: Today we pray for
all the staff at abortion
clinics around the nation.
May they be daily
confirmed in the sacred
care that they offer women.
- Day 27: Today we give
thanks for abortion
providers around the nation
whose concern for women
is the driving force in their
lives.
- Day 40: Today we give
thanks and celebrate that
abortion is still safe and

legal.

To respond to each of those “prayer” intentions:

- Day 5: Fewer and fewer medical students are interested in abortion. Aging abortionists are retiring and not being replaced.
- Day 18: Abortion — the destruction of innocent children — is considered “sacred care”? Unbelievable!
- Day 27: The “driving force” for Planned Parenthood is money. There is no prestige in the abortion trade.
- Day 40: Safe and legal? Based on numerous ambulance calls at abortion facilities, “safe” couldn’t be any farther from the truth. And of course, abortion is never “safe” for the baby.

Let’s all pray for all of those who’ve convinced themselves that abortion is a moral “choice” – and for all who are deluded into believing that lie.

In spite of all the shrill rhetoric ... the still, small voice of the Holy Spirit can reach the minds, hearts and souls of even the people on the inside
