**Pro-Lifers to Congress: Get Moving on Planned Parenthood Probe**

Last year, when a prominent chairman of a U.S. House committee announced he had sent letters to Planned Parenthood seeking information to begin an investigation into the nation's largest abortion business, pro-life advocates applauded. Now, there is concern the probe won't happen soon.

This morning in a hearing before the U.S. House of



Representatives Education and Workforce Committee, HHS Secretary Sebelius was questioned by Rep. Trey Gowdy (R-S.C.) on the topic of religious

liberty. Specifically, Rep. Gowdy questioned Secretary Sebelius□ statement in her testimony indicating the careful consideration she undertook to □balance□ religious liberty protections with preventive services in making the decision about the contraceptive mandate (which includes drugs that can cause abortions).

Rep. Gowdy asked the Secretary about the specifics of her □balance□. In doing so he explained three tests for legal balance, depending on the content and issues being weighed. 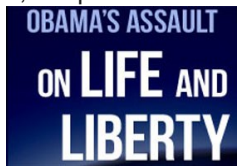
### **Protests Against Obama HHS Mandate Will Return June 8**

Obama forced funding of the research with public funds even though embryonic stem cells have yet to work successfully in animals because they cause tumors and face immune system rejection issues.

Sherley v.
