Our Lady of the Pillar -

Saragossa, Spain (ca. 40 AD)

After the crucifixion, resurrection and ascension of Jesus, his Apostles began to spread the message he left throughout Israel and shortly thereafter, through the Roman empire. One of these Apostles, James (the Greater), reportedly travelled as far west as Spain to the village of Saragossa in north east Spain. While James was there, he became disheartened because of the failure of his mission. Tradition holds that while he was deep in prayer Jesus' Blessed Mother appeared

to him and gave him a small wooden statue of herself and a column of jasper wood and instructed him to build a church in her honor:

"This place is to be my house, and this image and column shall be the title and altar of the temple that you shall build."



The jasper column and the wooden statue can still be seen on special occasions at a church that houses them. About a year after the apparition James arranged to build a small chapel in Mary's honor, the first Church ever dedicated to the honor of the Virgin Mary. After James returned to Jerusalem, he was executed by Herod Agrippa in about 44 AD, the first apostle to be martyred for his faith. Several of his disciples took his body and returned it for final burial in Spain. The local queen, observing several of the miracles performed by James' disciples, converted to Christianity and permitted James' body to be buried in a local field. Eight centuries later, a cathedral in honor of St. James was erected after his gravesite was rediscovered by a local hermit. The hermit found the burial site after noticing an unusual star formation. The site for the cathedral was called Compostella (starry field) and it is a major pilgrimage site to this day.

Pro-Life Group Details Pro-Abortion Views of Likely Obama Supreme Court Picks Washington, DC (LifeNews.com) -- A leading pro-life legal group has compiled a detailed analysis of the pro-abortion views of the several leading contenders from which President Barack Obama is expected to pick the next Supreme Court justice. Americans United for Life indicates pro -life advocates should expect a fierce battle over abortion with virtually any of the leading candidates. Elena Kagan, the Solicitor General of the United States and the former dean of Harvard Law School, has made the high-end of the list of potential nominees from most political observers. AUL indicates Kagan is at odds with a Supreme Court decision that upholds the right of government to stop taxpayer-funded abortions. Justice Leah Ward Sears. the chief justice of the Georgia Supreme Court, is another potential pick. Justice Sears has not issued any known decision on life-

related issues, but AUL indicates "Sears has evidenced a broad conception of substantive constitutional privacy -- the very basis upon which Roe v. Wade is predicated." Another potential Obama pick, Kathleen Sullivan of the Stanford Law School, is pro-abortion as well. "Sullivan, who has no judicial experience, published an article in the August 1992 New Jersey Law Journal, commenting on the U.S. Supreme Court's decision in Planned Parenthood v. Casey and arguing that legal status of abortion should be decided by the courts, particularly the U.S. Supreme Court, and not the American people through the democratic process," AUL indicates.

Pro-Life Groups May Have to Lead Battle Against Pro-**Abortion Supreme Court** Pick

(LifeNews.com) -- There is a growing feeling in the nation's capital and within the pro-life community that prolife groups may have to lead the fight against a proabortion Supreme Court pick. With their numbers sagging and even the ability to mount a filibuster appearing to be beyond their grasp, Senate Republicans are already sounding defeatist tones. They appear to be ready to truckle to pro-life and other outside groups, which are geared up to take on Obama and his expected proabortion Supreme Court nominee. Sen. Jeff Sessions, the pro-life lawmaker who is the new top Republican on the Senate Judiciary Committee, and top Republican aides appeared dispirited in recent comments to the New York Times. "Well, the Democrats have a strong majority on the committee," he said, referring to the fact that Senate Democrats now hold a 12-7 majority on the panel, shifting from their 11 to 8 majority before Senator Arlen Specter changed parties. "Assuming no serious problems, we should have a good discussion about the role of a judge," he added. Sessions didn't appear to believe that Obama's nominee would be defeated unless the nominee wanted "to promote a political agenda" or had problems such as tax payment or personal issues.

Tennessee Pro-Life Advocates Get Big Victory, **House OKs Abortion** Amendment Nashville, TN (LifeNews.com) -- The Tennessee state House has approved an amendment that pro-life advocates have fought for to limit the reach of a pro-abortion state Supreme Court ruling. The amendment, pro-life advocates say, is critically needed to be able to pass laws to limit and reduce abortions. The amendment is necessary because the Tennessee Supreme Court ruled 4-1 in 2000 that the state constitution allows unlimited abortions. The ruling claimed the Tennessee Constitution contains a fundamental abortion right even broader than Roe v. Wade or the federal constitution and it resulted in the striking down of numerous

pro-life Tennessee laws that were helping women and limiting abortions. The Senate-approved amendment, SJR 127, received a strongly bipartisan 76-22, to the delight of Ed Albin of Tennessee Right to Life, which has spearheaded the lobbying for it. "After a nine-year struggle by Tennessee's pro-life grassroots movement to force a House floor vote on the proposed constitutional amendment, the House has finally joined the state Senate which has already passed SJR 127 five times since 2000," he told LifeNews.com. Although the legislature finally approved the amendment, Albin explains that the battle continues and pro-life advocates need to prepare for continuing the battle next year.
