

Obama Admin Blocks Release of Study Showing Abstinence Education Works Washington, DC -- The Obama administration is, once again, entangled in controversy over sex education.

Yet this time, it is not

about what the administration is trying to implement, but about what it is withholding – and apparently for political reasons.

A taxpayer-funded study that indicates parental and adolescent support of abstinence education is not being released by the U.S. Department of Health and Human Services (HHS), as it does not support the administration's objective – or that of vocal "safe sex" activists – of eliminating all abstinence-education funding.

The Administration for Children and Families (ACF), a division of HHS, funded a survey of 1,000 adolescents between the ages of 12 and 18 and their parents, in order to measure parentadolescent communication and adolescent attitudes toward sex and abstinence.

The American Public

Health Association's (APHA) website reveals the results of the study:

"Adjusting for all other factors in the model, parent and peer factors are more consistently associated with differences in adolescent attitudes about sex and abstinence than are measures of adolescent exposure to sex and abstinence topics in a class or program.

Additionally, parent attitudes are more important in influencing adolescent views than the level of parent communication with their adolescent."

Catholics United protestors claimed the SBA List is lying about funding for abortion in health care because of an executive order issued by President Obama.

The problem with their argument is that the executive order doesn't hold any legal weight, isn't worth the paper it's written on, and does not

even attempt to address all the funding problems in the bill.

Support for Repealing Pro-Abortion Health Care Bill Highest in One Month

Washington, DC (LifeNews.com) -- Support for repeal of the health care reform bill that funds abortions is at its highest level in over a month, while the number of voters who believe repeal will be good for the economy has reached a new high.

The latest Rasmussen Reports national telephone survey of Likely Voters shows that 60% at least somewhat favor repeal of the health care reform law, while 36% oppose repeal.

Those numbers include 50% who Strongly Favor repeal and 26% who Strongly Oppose it. Platinum Members can see state-by-state results from across the country.

The number that favors repeal is up five points from last week and is the highest level measured since July 1. The number that Strongly Favors repeal also ties the highest level ever - first measured in mid-April.

Overall support for repeal has ranged from 52% to 63% since the law was passed by Congress in March.

Fifty percent (50%) of voters now say repeal of the bill will be good for the economy. That's up six points from the end of July and is the highest result found since the question was first posed in April. Twenty-six percent (26%) say repeal of the bill would be bad for the economy, while another 15% say it will have no impact.

Second Pro-Life Freedom Ride Focuses on Election, Helping Women After Abortion Washington, DC



(LifeNews.com) -- The first Pro-Life Freedom Ride in Alabama and Georgia saw hundreds of pro-life advocates recreate the historic rights used by the civil rights movement -- this time to press for civil rights for unborn children. The second ride takes place this September and will focus on the elections and helping women after abortion.

The event, sponsored by Priests for Life along with black pro-life leader Alveda King, was inaugurated last month with a ride from Birmingham to Atlanta.

The second phase begins next month with a nine-week period of prayer and action starting on September 1 and concluding on Election Day.

Participants and supporters will join a national webcast on September 7 to discuss how people can participate in their own communities in the activities of these weeks.

The event will also include the National Voter Registration Sunday projects on September 12, where pro-life advocates are urged to get church members and pro-life people registered to vote.

Then, the pro-life freedom riders will board buses and tag along in automobiles as they drive from Knoxville, Tennessee to Chattanooga.

Addressing Abortion
From a "Positive Angle"
Tough to Do When It
Kills Children

A Christian leader recently asked me to talk about abortion from a "positive angle" -- here is my attempt.

Abortion is positively an act of homicide – Homicide is defined as one person killing another person.

Abortion is positively the killing of a human person – Every single person aborted is a unique, full and equal human person in a different stage of their life. Zygote, Embryo, Fetus, Infant, Toddler, Teen, Adult, Senior Citizen: all stages of the life of a human person.

There are positively no exceptions that justify abortion - Because abortion always ends the life of a human person, there is no way to justify this homicidal act. While there may be tragic circumstances that lead to the conception of some human persons, this does not change the genetic make up or value of that individual person. While the mother carrying that individual human person in her womb may have medical complications, this does not justify killing that human person.

We would never accept the killing of a three year old to save the life or protect the health of a mother; in the same manner we cannot accept the killing of that same person when they were at an earlier stage of their life.

Pennsylvania Pro-Life Candidate Pat Toomey Holds Big Lead Over Joe Sestak

Washington, DC (LifeNews.com) -- Pat Toomey, the pro-life candidate for the Senate in Pennsylvania to replace pro-abortion Sen. Arlen Specter. has taken a big lead over his pro-abortion rival Joe Sestak. A new survey from Public Policy Polling, a Democraticleaning firm, shows Toomey jumping out to a 9-point lead, 45-36, with 20% still undecided. That's a big difference

from the June poll from the firm showing the race dead even at 41 percent.

Sestak gets only 64% of **Democrats to Toomev's** 74% of Republicans, and Toomey's support among unaffiliated voters is now a majority, 50 -23. Sestak also now has a net-negative favorability rating by 10 points, after breaking even in June, while Toomey keeps a barely positive mark. The polling firm says its surveying of likely voters finds a much different group of people turning out this November than in the presidential elections that resulted in the election of pro-abortion **President Barack** Obama.

"The likely 2010 electorate reports voting for John McCain by 1 point over Barack Obama, as opposed to Obama's actual 10-point victory," PPP said of likely Pennsylvania voters.
