**TRUSTEE JOHN DORNEY:** Experience with the Brockton VA. I've been trying to do this for 12-15 years. I went in for a procedure and they made you do a lot of paperwork. I went in and all I needed was my DD-214 and how much money I made last year. I sat down for an intake which took about 15 to 20 minutes and I went home. 3 days later I get a phone call that your enrolled, come in to take a picture, 3 days later I get my VA Card in the mail. Less than a week for the whole thing. 2 days later get a call asking if I want a Primary Care from the VA? Next day I get a call for a hearing test. And later I got \$6000 worth of hearing aids. The whole experience was transparent.

**JUDGE ADVOCATE:** Spoke about the Veterans Luncheon the 2<sup>nd</sup> Wednesday of the month at D'Anns Restaurant in Abington. Time we meet 12:00 noon. Cost \$13 includes drink and gratuity.

**SURGEON:** Spoke about the Burn Pits. K2 VETERANS TOXIC EXPOSURE ACCOUNTABILITY ACT. 7,000 U.S. Troops deployed from 2001-2005 at Karshi-Khanabad, a former Soviet base. They were exposed to depleted uranium, chemical weapons such as cyanide in the showers, and fuels and solvents as toxic black goo. Out troops have a 500% higher cancer rate and are now dying at an increasing rate. The VA and DOD refuse to acknowledge relationship between deployments and cancer. Our troops suffered from Agent Orange from Vietnam and from burn pits in Iraq and Afghanistan.... THIS CANNOT HAPPEN AGAIN! Write a letter of Support to Rep Mark Green, M.D. R-TN and Rep Stephen Lynch D-MA. Would like Post 6258 to send in a letter.

Also Metoquin (malaria drug) was discussed which causes brain stem damage. And has lots of side effects causes mood swings, anger, etc.

**COMRADES IN DISTRESS:** We have a WWII Vet Jim Ingargiola from Iwo Jima and Korea. He has cancer in the neck and is in a wheelchair but he is as sharp as a tack! He also has cancer in both lungs and they say its under control. And the VA is providing for a lot of his prescriptions but, they are sending him bills \$600 to \$800 dollars and expect him to pay out of his pocket. No Veteran should be going through this no matter who they are. So, we are helping Jim as much as we can.

**NEW BUSINESS / OLD BUSINESS: (a)** We will be displaying (6) 45 foot to 90 foot flags across the street by the Elementary School May 1st. Out of respect for the American Flags we will be laying them on top of tarps. We will meet around 11:30am or (to be announced). (b) Next year for the parade we will have a Marching Band from Kingston. We will lead with our Honor Guard. (c) Due to the coronavirus our visit to the Childrens Hospital is delayed to the Fall.
