Wings of Hope

Vietnam Veterans 2nd Battalion 1st Marines presented a copy of Wings of Hope by artist Todd Krasovetz to The Office of the Medical Officer of the Marine Corps honoring all naval combat corpsmen. Captain Mark C. Olesen MC USN, Assistant MOMC and Guest speaker accepted the painting.

The original painting "Wings of Hope" was unveiled Sept. 21, 2001 at the Naval Hospital, Camp Pendleton, CA. The painting depicts a fallen service member carrying his weapon being pulled to safety by a medical corpsman. "When I began this painting in March 2001, I didn't know that this painting would be so appropriate for today, especially after 9/11 and Operations Noble Eagle, Enduring Freedom, and Iraqi Freedom," Krasovetz said. "Wings of Hope" symbolizes the strength and brotherhood of the services. Even though, the models were from the U.S. Navy, they can represent any member of the armed forces. Soldiers, airmen, sailors, and Marines risk their lives in



the protection of freedom and to save their fellow service members.

MINUTES OF THE 2009 MEMBERS MEETING

The meeting was called to order at 0830 by President Paul Mangan.

Introductory remarks were made, a welcome given to the members and all first time attendees. There were 60 members in attendance as well as the members of the Board of Trustees and the Officers of the organization.

Minutes of the 2008 Members Meeting

Secretary Ben Dickson was introduced and an offering was made to read the minutes. A motion was presented to approve the minutes as posted in the newsletter Vol.6, issue 1. A second was received and vote taken. It was approved to accept the minutes as posted.

Treasurers Report

Mario Sagastume was introduced. He submitted a balance sheet and financial sheet detailing the finances of the organization. Discussion of the status of the treasury totals was given with the highlight being the donations from our last mailing generating over \$14,000.00 given by the members. Mario stressed the generosity of the members had exceeded the expectations of the trustees and board noting the members now were all accepted with no requirements for dues. A copy of the financials and balance sheet are available to all members upon request to Mario. Our dealings with the finances entrusted to trustees and the board are transparent and available to all members. A motion was made to accept the report as read and a 2nd was given. A vote was taken and approved that the report be accepted as given.

Presidents Message and Report

Paul welcomed everyone again to the meeting and expressed his gratitude to the board, trustees, and members for the efforts put forth this year to make the reunion a success.

Agenda items:

1. Conference calls: a discussion of the implementation of a system of conference meetings was given. They began in early January and were done by computer. That was switched to a phone system in the early spring. There has been almost 100% participation by the board and trustees. It has enhanced the quality and progress of the tasks needed to plan the reunion and greatly increased the efficiency of the results. Your reunion is a concrete example of the work done at these meetings. Paul stressed that anyone is free to listen in to these meetings and participate, and if requested will be given the codes to join the calls. The trustees and board will still be making a midwinter meeting to fine tune the details of the organization and implementation of the mission statement. Results and details of these meetings will be posted in a newsletter or on the website.

2. Paul reviewed the locations for the upcoming reunions and opened the discussion of the reunion for 2012. 2010 had been approved for San Antonio, Texas. 2011 had been approved for Memphis, Tennessee. These sites are locked in and further details will be given when the negotiations for prices and dates are approved. They will be given to the members in an update or newsletter as they become available. Paul has done the research on San Diego. The Oceanside site was not well received by the members last year. Paul has gone to many sites in the area and found the Mission Bay Resort on Balboa Island as a good candidate. It has amenities that are favorable to transportation, food, families, sightseeing, and shopping. It is in close proximity to Camp Pendleton and the airport. With a beach and many perks, it is well suited to our needs. The resort is being very generous on prices even though it is high season for vacation, and necessary meeting facilities are not available at any of the other nearby venues. A discussion by the members followed with questions about add-ons, taxes, and prices. Paul discussed the prices and they are the lowest for what we will get compared to the other resorts, and can be locked in now to avoid major price increases. A motion was made to go forward with the site for the 2013 reunion at San Diego, Mission Bay at the Bahia Resort. A second was given and a vote approved the motion.

3. Paul discussed what to do with the money generated by the members. Do we want to designate funds to be set aside to help others? Discussion followed about our reserves, designated funds, unrestricted funds and goals for such funds. Mario stated that we are in good shape financially, and at present are covering our expenses. It was discussed as to what we can and cannot do with our funds due to our tax status. Mario explained that designated funds are those that a member specifically says what he wants them to be for, i.e. books, shelters, banquet costs, etc. The undesignated funds are those that a member gives to help whatever the board and trustees feel is required or needed: i.e. donations to wounded warriors, Vets shelter, etc.. A motion was made to set aside up to 10% of undesignated funds to be used in a fund whose name will be determined at a later date. A second was given and a vote approved the measure.

4. Elections of Officers and Trustees: The membership also elected two new Trustees to fill the vacancies that occurred with Joe's passing and the expiration of the term of Phil Odom, (A special THANK YOU is owed to Phil for his hard work during his tour as a Trustee, especially his outstanding contribution to our Houston Reunion) Bruce Oliver and Gary Gordon were each elected to four year terms as trustees, welcome to the team gens.

Old Business

Thanks for all the work Phil put into the ID cards.

Vinnie gave us an update on the website details. We are getting 28 hits a day which adds up to approx. 10,000 per year. He will be setting up a new site map to make browsing the site easier. A list of brothers we have lost will be posted to help those searching for men.

Vinnie was given a huge thank you and round of applause for all of his efforts.

A member asked about the books, repayment to Mr. Novak and how that is progressing. Paul and Mario have been in direct contact with Dave and have worked out details that he is ok with to pay down and pay off the debt we owe to him.

New Business

No new business was brought up.

A motion was made to adjourn. A second was given and approved by voice vote.

The meeting was adjourned.

Scuttlebutt by John (Doc) Weed

Do you know about D.I.C.? It stands for Dependents Indemnity Compensation. When a Service Connected veteran receiving service connected disability payments dies all service connected payments stop. The surviving spouse may be eligible for D.I.C. which currently is about \$1100 per month. D.I.C. is not automatic and must be filed for using a Veteran Service Officer or VA Vet Rep. There are three ways in which the spouse may be eligible: 1) the veteran dies of a service connected illness (regardless of the percent disabled); 2) the veteran was 100% service connected for 10 years uninterrupted (cause of death does not matter); 3) the veteran was 100% service connected and listed as permanent and total (any time period and cause of death does not matter).

Go to www.va.gov and hyperlink to D.I.C. or search VA web site for D.I.C. That web site on D.I.C. will discuss eligibility and provide the form used for filing for D.I.C. The Veteran Service Officer or VA Vet Rep will also need a copy of the death certificate and possibly a letter from the Physician stating what the cause of death on the death certificate is and that it is the same as the listed service connected disability of the deceased vet.

We have no dues and, although always gratefully accepted, you need not send a Donation to become a member.
