During the annual meeting, (see the minutes for details of the 2/1 annual business meeting) one item of special note was the vote to investigate the cost and process of placing a 2/1 monument in the Semper Fidelis Memorial Park on the grounds of the National Museum of the Marine Corps in Quantico, VA. As we get more information we will post the results in the 2/1 Email Update and subsequent Newsletters. If the cost and process is reasonable, and there is enough confidence in our ability to raise the funds to complete the project, it will be brought to a vote at this year's annual meeting in San Diego. If the membership approves the monument the objective would be to have it completed in time for us to dedicate it when we hold our reunion in Washington, DC next year (2013).

The 2012 reunion in San Diego, on beautiful Mission Bay, is from November 8 through the 15<sup>th</sup> and the location is one of the best reunion hotels we've ever had in Southern California. This year's reunion dates work out well for those of you that may only have extended weekends to get away for reunions. **Annual Business Meeting - Olive Branch Mississippi****V V OF 2/1 GENERAL MEMBERSHIP MEETING  
12 NOVEMBER 2011**

The meeting was called to order by President Paul Mangan at 0915hrs. A roll call of all officers and trustees was called. Gary Gordon was not present, all others were present.

The minutes from last years meeting were posted to the newsletter update in January of 2011. Waived reading of the minutes.

It was requested that we open with the pledge of allegiance and a motion was made and approved to open all future meetings with the pledge. All present recited the pledge of allegiance.

**Presidents Report**

1. A discussion was opened regarding our organization being a "last man standing", or opening it up to other members to keep it going.
2. The president gave details of how we have put in place a method to reach out and help the OIE vets start their own group if they so desire. A question of our assets was brought up and if we had a succession plan. It was discussed about how the younger men are very connected with social media, etc. and do they need or want to be in our group or have their own group. After many comments, a motion was brought forth and passed to have the board research how we can expand our organization to include brothers from other conflicts and maintain our own identity and to come up with a plan for our assets. The results of this research will be brought to the membership at the San Diego reunion.

**Treasurers Report**

1. Mario made a statement on the transparency of the books, organization and assets to remind us that our board meets on a regular basis and periodically reviews the financials to insure all is in order and above board.
2. A reading of the financial statement was given and a discussion of the balance sheet was read. It was reminded that the documents are available to anyone but we do not post them to the web for everyone to see.
3. The financial statement and balance sheet was approved as read.

**Committee Report**

1. Membership: The report from Gary Gordon was read and outlined the increase in the numbers added to the roles for the last year. It detailed what a great job the committee and Bruce Oliver have done to enhance the membership roles and the mailing list. Much work has also been put in by Phil, Mario, and Vinnie. Kudos to these gentlemen.

**By Law changes recommended:**

1. "Audit of the budget: At each annual business meeting, the Association Treasurer... will present an overview of income and expenses (the books) for the budget year ending 30 September. In addition, the "books" are open and any member may request to see a copy of the Association's expenses and income for that year. A vote of the members present shall be taken on whether or not an audit of the treasurer's records will be conducted. However, an audit by a reputable CPA firm is very expensive. A majority vote requires the Association to have an audit conducted with the expense of the audit paid from Association assets. Should any member wish to have an audit conducted when a majority of members have voted "No", such audit may be conducted solely at the expense of the dissenting member(s). Should an audit determine that improprieties have occurred with the finances, then the cost of such audit if paid by member(s) shall be reimbursed by the association.

A call for discussion. Several questions regarding the costs of audits were clarified by the president. A call for the vote was made and a 2nd confirmed. The vote carried.

2. Chaplain: "The President may appoint an Association Chaplain whose... responsibility is to provide spiritual assistance to any member who requests such assistance and to conduct services as assigned by the president." The Chaplain provides religious guidance and solace for the 2/1 Marines, bothers, families, and friends. When requested by 2/1 and /or the members, the Chaplain will to the best of his ability: participate in 2/1 events, answer questions, offer guidance, or offer counseling. The Chaplain will act in a non-denominational capacity respecting all religious and nonreligious beliefs.

A call for discussion. Questions about the Chaplain serving as the president appoints, was clarified. A call for the vote was made. A 2nd was confirmed. The vote carried.

**Old Business**

1. Phone numbers of the board will be posted to the newsletter. They are currently on the web page also.

**New Business:**

1. A monument is suggested to be placed at the National Museum of the Marine Corps. (NMMC).



**From Dale Williams**

When I was introduced at the Birthday Ball as the FNG Trustee, I knew I was in trouble. I remembered how they got all of the "good" details. I can't wait to see the missions that I'm assigned.

I'll provide a little background to introduce myself to those that don't know me. I was with Fox Co. from Feb '69 to Feb '70. I was released from active duty upon return to CONUS, got married, started a family, participated in the active reserve, completed college and returned to active duty. I retired from the Marine Corps in 1995. I have been a member of the organization since 1991 but only attended one reunion prior to 2009.

How I found the organization and my disappointment in meeting only one person that I had served with is what finally got me off the dime so to speak and start participating. I was actually in Kuwait when I saw the announcement in Leatherneck about a 2/1 reunion. When I returned to the States I got in contact and joined. I finally went to a reunion in Charleston in the late 90's. Jim Kirk, who has attended almost every year, was the only one there that I had known in country. As great as it was to see him, it was disappointing that he was the only one. Sometime in the summer of 2008 I realized that the next year would be the 40<sup>th</sup> anniversary of my Vietnam experience. I thought about how much I wanted to see the guys that I had gone through it with. Over the years I had had seen two, Jim Kirk and Don Huth, and had telephone contact with two others. At that point I set out to find as many as I could.

I won't go into the detail of the searches but so far I have contacted over 30 that were in my platoon or attached to it during '69. Over the last three reunions we have had an average of 10 guys and 7 wives attend, 16 different individuals and 13 wives. My point in all of this is it takes someone close to the individual to make contact and tell them about the organization. Someone that shared the experiences to find them and let them know we are here.

I want to thank those that founded the organization and those that have kept it going. I hope that I can make a positive contribution and that we continue to have reunions that maintain the quality of the past several that I have attended.

Following, is a brief summary of the report presented during the business meeting in Olive Branch, November, 2011. The results are for the fiscal year ended September 30<sup>th</sup>, 2011:

Cash and inventory	<u>\$28,112</u>

The Trustees agreed not to have a donation drive in 2010 which resulted in reduced revenue compared to the prior fiscal year. The plan is to request donations from the membership bi-annually. The Organization remains solvent as you can see by the balance in Current Assets against no debt. Thanks for the generosity, support and confidence you have demonstrated at the reunions and purchasing items from our PX.

### Monument to Vietnam Veterans of 2/1

The membership at the 2011 Annual Business Meeting voted to move forward on pursuing the establishment of a monument to the Vietnam Veterans 2nd Battalion 1st Marines to be located at The Semper Fidelis Memorial Park, which is adjacent to The National Museum of the Marine Corps in Triangle, Virginia. [see the minutes of the meeting].

This project will not proceed, until all the details and costs are explained at this year's annual 2012 San Diego meeting, and the membership votes to go forward with the project.

This undertaking will require input from the membership, extensive planning and will be somewhat expensive. Funding will be by donations specifically designated for this project. However, it will be a fitting memorial to all the Marines and Corpsmen who served with the battalion in Vietnam.

Most of the monuments that have been approved to date are based on classical geometric shapes. Examples of installed monuments can be found at the Museum's web site, [www.usmcmuseum.org](http://www.usmcmuseum.org) and <http://www.klinememorials.com/veteranscivic-memorials>

A committee made up of Officers, Trustees, and members will be established for oversight and coordination. All members are encouraged to submit their ideas. V V 2/1 will have to provide a detailed design including dimensions, a materials list, any text to be included, name of sculptor or manufacturer, and a sketch of the finished proposed memorial to the Marine Corps Heritage Foundation for approval. Upon approval, the design will be referred to a selection committee chaired by the President, Marine Corps University.

Some of the requirements: Footprint for the monument shall not exceed 9 square feet in an area 6 feet by 6 feet and the height must not exceed 10 feet. Avoid features that collect water. No moving parts are allowed. No external lighting is allowed. Avoid features that can be easily climbed on, swung upon, or otherwise be broken from visitor interaction.

Consideration should be Granite and bronze are the most commonly used materials and work well together, but bronze and marble do not.

The cost is estimated at \$10,000-\$20,000. Donations would be made through a special program set up by the Association. (Similar to the designated funds for the Esprit de Corps Fund currently in operation.)
