Greetings Brothers, Families and Friends of 2/1,

It's hard to believe that it has been only a few months since the 2007 reunion and now we are hard at work on our 2008 gathering at Camp Pendleton, Oceanside this November. In this issue of the 2/1 Newsletter you will get the scoop on where to be for this years reunion as well as an update on the activities and business decisions from our 2007 annual meeting.

First the details on the 2008 reunion in Oceanside, Ca., the dates are November 7 – 12, 2008 and we will again have Marty's Valley Inn, as our host hotel. This will be our third or fourth reunion at Marty's and they are giving us a great rate and setting aside enough rooms so every 2/1 Brother, their families, and our extended family of 2/1 friends will have a place to stay. The folks at Marty's, led by general manager Andrew Stewart, are making rooms available for our group at only Sixty Five (\$65.00) bucks per night when you call them at either, toll free - 1-800-747-3529 or local at 760-757-7700. The Address is Best Western Marty's Valley Inn. 3240 Mission Ave. Oceanside, CA. 92054

You will notice that the reunion sign up form has two numbers for the hotel, the 800 number and the local direct dial number, there is a reason for both of them. While the 800 number is direct to Marty's Valley Inn, if they are busy and cannot get to the phone soon enough, your call may be routed to the Best Western Hotel national call center. If you are routed to the national call center the staff at Marty's suggest you hang up and call back later and most likely get connected directly to the hotel. The reason for the suggestion to hang up if you're connected to the call center is that you may not get the special rate of \$65.00 if you book your rooms through the center. The other phone number; **760-757-7700 while not toll free, is direct to Marty's Valley Inn and once you tell them you're part of the Second Battalion, First Marines reunion you will get the discounted room rate.**

A special welcome was given to over 30 new members and first time attendees.

A call for a reading of the minutes was given and it was moved to waive reading of the minutes due to their posting on the web. Those requesting a copy would be given a copy by the secretary. The motion was approved by a voice vote from the membership.

Presidents Report:

This reunion is the result of the work of the Officers, Board of Trustees, committees, volunteers and chair Phil Odom. Thanks was given to all and well done to Phil for all of the hard work and effort he has put into it to benefit the members and families.

The officers and board held a mid-winter meeting in Houston to discuss detail planning of issues and goals related to the operational plan set up at last years meeting. Items affecting the membership and organization were studied and work has been ongoing to accomplish a resolution to the issues involved.

- 1. Item one:** Liaison has been established with the Executive Director of the 1st MarDiv Association. Col. Len Hayes was a company commander with Fox 2/1 and has worked with Paul Mangan to get them to establish a new class of membership pertaining to us. This would give us autonomy but allow us to be included as members of the association as a unit. We, as 2/1, are now members of the 1st Marine Division Association but retain our independent status as an organization.
- 2. Item two:** We now have a PayPal account that allows us to accept payments over the internet and at our meetings. It will expedite our revenue intake and accounting.
- 3. Item three:** A roster of members has not been established for posting on our site due to privacy issues. Vinnie has worked on this and will establish a vehicle to accomplish the goal of allowing contact information for members to access, while retaining the privacy aspect of it. The details will be put in the newsletter, updated and given to members who request it. Security issues were discussed and will be researched.
- 4. Item four:** Our issues with regard to 501C3 status have been resolved. Status is confirmed. Any donations are tax deductible. Any expense incurred in work related to the association for the benefit of the membership, required by your position is tax deductible.

Treasurers Report:

A list of the financials and the report is available to all members who request it. Mario has copies for inspection. Contact Mario at: **choncho0331@sbcglobal.net** A review of the details was given by Mario. We are in good shape financially and our position will improve due to most of the items for the reunion being donated.

Questions were asked regarding ways to save money on our biggest cost items such as the newsletter. Research has been done and these are being worked on and reductions have occurred. We are moving forward to continue to find ways to save money, but give the membership the best possible use of the funds we have.

The issue was brought up about investing some of our capital to generate revenues to be used for the organizations work. This will be researched and put on the agenda for the Board to resolve.

Mario is keeping up with the P.X. and it has been a revenue generator for us. Members are encouraged to buy items from us if possible.

Texas Tail Gate Party




Hospitality
