Annual Mid Year Business Meeting - Olive Branch Mississippi**Annual Business Meeting**

In addition to the usual agenda items scheduled for the Annual Business Meeting of the Association there will be several agenda items that will require your vote. Among those items are the following;

Shall the By-Laws of the Vietnam Veterans of the 2nd Bn. 1st Marines be amended with the following addition(s)

AUDIT of the BUDGET

At each annual business meeting, the Association's Treasurer will present an overview of income and expenses [The Books] for the budget year ending 30 September. In addition, the "Books" are open and any member may request to see a copy of the Association's expenses and income for that year.

A vote of the members present shall be taken on whether or not an audit of the Treasurers records will be conducted. However, an audit by a reputable CPA / Firm is very expensive.

A majority vote requires the Association to have an audit conducted with the expense of the audit paid from Association assets.

Should any member wish to have an audit conducted when a majority of members have voted "NO", such audit may be conducted solely at the expense of the dissenting member[s].

Should and Audit determine that improprieties have occurred with the finances, then the cost of such audit if paid by member[s]. shall be reimbursed by the association.

Chaplain

"The President may appoint an Association Chaplain whose responsibility is to provide spiritual assistance to any member who requests such assistance and to conduct services as assigned by the President."

The Chaplain provides religious guidance and solace for 2/1 Marines, brothers, families, and friends. When requested by 2/1 and/or the members, the Chaplain will to the best of his ability: participate in 2/1's events, answer questions, offer guidance, or offer counseling.

The Chaplain will act in a non-denominational capacity respecting all religious and non-religious beliefs.

Reunion Guest Speaker Dr. Andrew A. Wiest, PhD - University of Southern Mississippi.



Dr. Andrew Wiest, Professor of History at the University of Southern Mississippi specializes in the study of World War I and Vietnam. He has served as a Visiting Senior Lecturer at the Royal Military Academy, Sandhurst in the United Kingdom and as a Visiting Professor in the Department of Warfighting Strategy in the United States Air Force Air War College. Since 1992 Dr. Wiest has been active in international education, leading a study abroad program on World War II and developing an award-winning Vietnam Study Abroad Program. Dr. Wiest has presented his research at conferences both nationally and internationally, has appeared on several documentaries for the History Channel, Granada Television and Lucas films, and has served as a commentator on military events for national news outlets including the San Francisco Chronicle and the Philadelphia Inquirer.

His several publications include **The Vietnam War, 1959-1975**, Osprey Press, October 2002. **The Illustrated History of the Vietnam War**, (Co-authored with Chris McNabb) Thunder Bay Press, October 2000 and **Rolling Thunder in a Gentle Land: The Vietnam War Revisited**, Osprey Press, September 2006.

At present Dr. Wiest is working on a range of projects, including an article on the U.S. advisory effort in the Vietnam War, including an archival project which will follow the men of Charlie Company, 4th Battalion, 47th Infantry during their tour in the Vietnam War. The study will rely on oral histories and archival sources to tell the story of Charlie Company, which was raised specifically for the war, from its training through its year in combat. The study will then move on to investigate the lives of the men after they returned from Vietnam and reintegrated into American society. Dr. Wiest lives in Hattiesburg, Mississippi with his wife Jill and their two children Abigail and Luke.
